The meeting was held at Gail's home and called to order at 3:05 pm.

The minutes of the prior meeting (January 15, 2026) were approved.

### Treasurer's Report – Sally Glavin

- Sally provided a current Income/Expense Summary which reflected that we are tracking well within budget. Expenses from the Return to Oz event, including luncheon & guest fees, will be booked upon receipt of the February Golf Club statement.
- PL9 has a credit of \$275 with the ProShop as of January statement. This credit will be used to purchase merchandise for member awards.
- Gift certificates of \$20-\$25 each will be issued to all 46 members at end of season.

### Events – Nury Duerst

- The **Return to Oz** Member/Guest event was well attended with 52 participants and deemed an enormous success overall. Minor changes for next year were noted – reducing required drives per player from two to only one, consideration for orange tee players and recognition for both gross & net score leaders.
- March 10<sup>th</sup> will be an 8:30 am shotgun to accommodate the PL18 Invitational.
- There will be no league play on March 17<sup>th</sup> due to the St. Patrick's Day tournament.
- The two-day **Queen Bee** Event will take place on March 23<sup>rd</sup> & 24<sup>th</sup>. ProShop will be reminded to reflect Day 1 scores on Day 2 score cards so players will know if they can pick-up ball. Players will hit from their designated tee box (Orange or Red). The Queen Bee will be crowned on March 24<sup>th</sup> and awarded a special gift provided by John Whitenack. Two runners up will also be recognized.
- **Closing Day** will take place on March 31<sup>st</sup> and will be followed by Awards & Recognition along with our annual AGM. Awards will be presented for most Pars, Birdies, Eagles, Best Attendance and Most Improved Golfer. Complimentary drinks will be provided.

## **Leadership**

- Nury has modified the **Willingness to Serve Form** for the 2026-2027 season which will be distributed electronically to membership, along with descriptions of what each role entails. Members will be asked to return forms by March 17<sup>th</sup>, 2026.
- Due to the shortened season caused by the golf course closure in April, it was decided that the PL9 will forego distributing a year end membership survey.
- Some members have made special requests to be paired with specific members for league play. Nury has prepared an email response to explain that the purpose of the PL9 is to mix and mingle with all members and in keeping with this philosophy, special pairing requests will not be considered for regular league days.

- A tentative date of March 2<sup>nd</sup> has been set for the owners of **FK your Diet** to make a presentation to membership. Appeals for donations of duffle bags and linens have been made to the PL18GA as well as the MGA and many donations have already been collected. The presentation will be open to all residents of Somerset.
