Treasurer's Report – Sally Glavin

- Based on the success of 50/50 ticket sales, each member will be issued a \$20 gift card at Season Closer on March 31st. Gift cards do not expire and can be used for Pro Shop merchandise.
- The PL9 has accumulated shop credit throughout the season, and this credit was used to purchase merchandise that will be used for prizing next season.
