PRIVACY POLICY

BMGNY Pty Ltd trading as RNEW MY TM ACN 33 144 962 827 (**BMGNY**, **we**, **us**, **our**) is committed to protecting your privacy. This Privacy Policy tells you about how we collect, use and disclose your personal information when you use our website ("RNEW MY TM Website"). The RNEW MY TM Website is registered by BMGNY Pty Ltd and may be accessed in Australia and overseas.

By visiting and/or using the RNEW MY TM Website, you agree to the terms of this policy and you give your consent to our collection, use and disclosure of your personal information or personal data (**personal information**) in accordance with this Privacy Policy.

The collection, use and disclosure of your personal information is governed by the *Privacy Act 1988* (Cth) if you are in Australia, the EU or UK General Data Protection Regulation (**GDPR**) if you are in Europe or the UK, or similar legislation applicable to where you live. For data protection purposes we are the controller and, unless otherwise noted, also the processor of data.

The RNEW MY TM Website has been created to help clients protect their Intellectual Property rights, namely trade marks.

The personal information we may collect

The type of personal information we collect and hold may vary depending on the purpose for which you are using the RNEW MY TM Website. The personal information which we collect may include any or all of the following:

- name;
- email address;
- telephone number;
- username and password;
- location data including your geographic location;
- financial information such as bank details, credit card number and billing address.

Collection of personal information

BMGNY only collects personal information that you want to give to us or that is needed to provide and improve our service to you. You may give us your personal information directly such as when you deal with us in person, online, by email, post and facsimile or over the phone. Personal information will be collected when you first register to have dealings with us and is collected so that you can more easily do business with us. Financial information such as your credit card number and billing address is collected so we can process transactions and provide you with products and services.

You can choose not to provide personal information, but this means certain products and services may not be available to you or may not have the functionality that you would otherwise get. You can withdraw your consent at any time by contacting BMGNY at contactus@rnewmytm.com.au.

BMGNY will not ask you to provide sensitive information eg health information, political affiliations, religious beliefs or criminal convictions. If for any reason we need to collect sensitive information, we will first ask you to opt in to its collection, use and disclosure in accordance with this Privacy Policy.

BMGNY tries to collect personal information directly from the relevant person. However, if this is not practical, we may collect personal information from third parties or publicly available information. If you give us personal information about another person, you must ensure you have the right to disclose that personal information to us.

Cookies and other technologies

Other kinds of information may be collected automatically. This includes your IP address, browser type and language, access times and the website that referred you to us. We may also collect navigational information, including information about the pages you view, the links you click, and other actions taken in connection with our website. We may combine your visit and navigational information with personal information that you provide.

We use "cookies" to enable you to sign in to our services and to help personalise your online experience. A cookie is a small text file that is placed on your hard drive. Cookies contain information, including personal information that can later be read by a web server in the domain that issued the cookie to you. The information that cookies collect includes the date and time of your visit, your registration information, and your navigational and purchase history. Cookies offer you many conveniences including saving you time by eliminating the need to repeatedly enter the same information.

In some cases, our third-party service providers may use cookies on the RNEW MY TM Website. We have no access to or control over these cookies. This Privacy Policy covers the use of cookies by BMGNY only and does not cover the use of cookies by third parties.

You have the ability to accept or refuse cookies. Most browsers automatically accept cookies, but you can usually modify your browser setting to refuse cookies. If you choose to refuse cookies, you may not be able to sign in or use other interactive features of our website and services that depend on cookies.

In addition to cookies, BMGNY may use other technologies, including single-pixel gifs (also known as web beacons) on our websites and in promotional e-mail messages or newsletters. These tiny electronic images assist us in determining how many users have visited certain pages or opened messages or newsletters. BMGNY does not use these images to collect personal information.

Use of Your Personal Information

BMGNY uses your personal information for purposes which are consistent with why we asked you to provide the personal information, or for a directly related purpose. Such purposes include:

- assist response to emergency situations;
- doing business with you so that you can purchase our goods and services;
- effectively communicating with you;
- operating and improving our website;
- providing customer service;
- performing research and analysis aimed at improving our products and services;
 and
- displaying content that is customised to your interests and preferences.

Sharing of Your Personal Information

BMGNY does not sell, rent or trade your personal information to or with any third parties.

You consent to BMGNY sharing your personal information with external service providers who perform services on our behalf. For example, BMGNY may hire other businesses to handle the processing of payments, provide data storage, host websites, fulfil orders and shipments, assist in direct marketing, conduct audits, etc. BMGNY only gives those businesses the personal information they need to provide the service. BMGNY will take all reasonable steps to make sure they comply with the same privacy principles that govern our collection and use of your personal information.

We may disclose your personal information if required to do so by law, or in the good-faith belief that such action is reasonably necessary to comply with legal process, respond to claims, or protect the rights, property or safety of our company, employees, customers, or the public.

Where your personal information may be sent and/or stored

BMGNY and some of our external service providers may not be in the country where you submitted your personal information. As a result, your personal information may be transferred to countries that have different levels of data protection laws to where you are. Countries in which we store personal information include Australia and the USA. Where local data regulations require it, BMGNY has (a) put in place security measures for the export of personal information from its country of origin; and (b) made arrangements with those receiving your personal information, that they will put security measures in place and that your personal information is processed in accordance with relevant data protection laws. However, as we cannot guarantee ongoing compliance by third parties, by giving us your personal information, you consent to the disclosure of personal information to overseas service providers who may not comply.

Marketing

BMGNY may send you surveys or marketing communications to inform you of new products or services or other information that may be of interest. Third parties with whom we have shared your personal information may send you direct marketing communications.

If you do not want to receive direct marketing communications from either us or a third party, it is easy to opt out. You can send BMGNY an email request to contactus@rnewmytm.com.au or press the "unsubscribe" button on the communication that is sent to you. Please keep in mind that, if you choose not to receive marketing communications, you will continue to receive transactional or account communications (e.g., confirmation emails and account balance statements). In the case of direct marketing communications from third parties, you may have to follow their directions on how to unsubscribe from their communications.

Your rights in relation to your personal information

You have, subject to certain exceptions allowed for by law, the right to ask us to provide you with all of the personal information we store on you. If you would like to get access to, review or correct any of your personal information email us at contactus@rnewmytm.com.au.

You are (among other things) entitled to:

- receive transparent information regarding the processing of your personal information;
- access your personal information, including the right to obtain free of charge a copy of the personal information undergoing processing in a commonly available electronic format;

- rectification of incorrect personal information and completion of incomplete personal information;
- erasure of your personal information, including the "right to be forgotten";
- restrict the processing of your personal information;
- your personal information being portable and accessible upon request;
- object to the processing of your personal information; and
- if you have consented to the processing of your personal information, you have the right to withdraw that consent.

If we have disclosed your personal information to a third party, in accordance with this Privacy Policy, we will take reasonable steps to notify the third party of the updated information.

We may not be able to provide you with all of the information requested if by doing so we would be disclosing a third party's personal information.

Security of Your Personal Information

BMGNY follows accepted industry standards to help protect your personal information. No method of transmission over the Internet, or method of electronic storage, is 100% secure. Therefore, while we strive to protect your personal information, we cannot guarantee its absolute security and any transmission of personal information is at your own risk.

If a password is used to protect your account and personal information, it is your responsibility to keep your password confidential and to change it if you think it has been compromised.

Retention of your personal information

BMGNY will only keep your information for as long as is necessary for the purposes for which you provided it to us. We may need to keep your personal information for a longer period in order to comply with our legal obligations.

Forums & Other Interactive Services

The RNEW MY TM Website may include discussion forums or other interactive areas or services, including blogs, chat rooms, bulletin boards, message boards, online hosting or storage services, or other areas or services in which you or third parties create, post or store any content, messages, comments, materials or other items on the websites (Interactive Areas). If you use an Interactive Area, you should be aware that these areas are open to the public and any personal information you post or provide at registration may be viewable by others. BMGNY is not responsible for personal information you submit in connection with the Interactive Areas, nor is BMGNY responsible for how others

might use that information, including sending you unsolicited messages. Interactive Area postings may be retained indefinitely. Keep in mind that removal of a posting from an Interactive Area does not mean that the posting will be deleted from our systems.

Children
