Town Now Accepting External Applications for Municipal Accommodation Tax Funding

The Town of The Blue Mountains is now accepting external applications for funding through the Town's share of the Municipal Accommodation Tax (MAT).

The MAT funding program is intended to support community-based projects, initiatives, and requests that align with Town priorities, including the Destination Strategy, Corporate Strategic Plan, and Economic Development Strategy, with a focus on delivering benefits for both residents and visitors.

The evaluation criteria reflect the Town's commitment to using tourism-generated revenues to help enhance public amenities and spaces, support local businesses, and strengthen tourism-related infrastructure, while reducing reliance on additional taxation for residents. By reinvesting MAT revenues locally, the program supports a positive cycle where visitor spending contributes to further economic activity and sustainable community growth.

"This new funding program will help ensure that MAT revenues are invested in a way that strengthens our community, supports the visitor economy, and delivers value for residents," explained Mayor Andrea Matrosov. "Council's evaluation criteria supports a consistent, accountable approach to funding decisions and will help applicants understand how proposals will be assessed."

Who Can Apply

Applications may be submitted by external organizations, including not-for-profit organizations, registered charities and Council-established Committees, Working Groups, and Task Forces.

Deadline

Completed applications must be received by Wednesday, March 4th.

Waste Collection

Curbside waste collection will occur as usual on Monday, February 16, and for the remainder of the week. Operations staff have provided additional reminders regarding collection:

- Weekly bag limit: the first garbage bag is free, the second bag requires one tag, and the third bag requires two tags. Each tag costs \$5.00.
- If you are placing your bins out the night before collection day, they must be placed at the curb after 7:00 p.m.
- All garbage, organics and recycling must be on the curbside by 7:00 a.m. on your collection day.
- The cardboard is to be flattened, cut into 18" x 24" pieces and placed next to your recycle boxes.
- Ensure the Full/Empty tab is tethered to your stationary waste box and fully visible to the collection crew.

Renewing Driver's Licenses,

Age 80 and over - There are often discussions among seniors or with seniors' family members, about renewing your driver's license when you reach 80 years of age. From then on, licenses need to be renewed every 2 years. The full requirements are clearly described on the website, Renew a G driver's licence: 80 years and over | ontario.ca If you don't have access to the internet, you could ask staff at your local library to help you find the website or talk with the staff at your nearest Service Ontario office.

At this time, (February 2026) the closest Service Ontario sites to renew your license are in Meaford and Collingwood. The Meaford location is 150 Sykes St N open 10 - 1 and 2 - 5 and the Collingwood office open 9 - 5 at 191 Hurontario St., Unit 6. (small plaza located between Hurontario and Ste. Marie Streets alongside the Giant Tiger store.) Both sites are fully equipped to do the driver's license renewal for those 80 and over, including the testing that is necessary. No appointments are necessary but there might be a wait.

Seniors Matters Today

Seniors Income Tax Benefits and Credits – March 12, 2026, 12 noon – 2:30 p.m. New Territory4Seniors Beaver Valley Outreach Lunch and Learn. Canada Revenue Agency (CRA) representative Sheena Barnett, Volunteer and Benefits Outreach Program, will explain the Canadian benefits and credits for your income tax filing. It will be a virtual presentation through Zoom.

Ms. Barnett will appear on the wall screen in The Gallery of L. E. Shore Library. She will be able to answer questions from the audience as well as present the most up to date information about the tax filing for the taxation year 2025. She will also provide contacts at CRA for individuals who want to discuss their specific situations. She will be present from 12 noon until 1:15 p.m. and a light lunch will follow. Handouts will be available as well.

Senior's income levels, CPP, etc. 2026

In 2026, seniors can expect an increase in their CPP and OAS payments due to the standard inflation adjustment. The maximum monthly CPP payment will be \$1,507.65, up from \$1,433.00 in 2025. OAS payments will remain the same for the January to March 2026 quarter at \$742.31 for those aged 65-74 and \$816.54 for those aged 75 and over.

Canadian Dental Care Plan (CDCP) coverage requires annual renewal to confirm eligibility. Everyone applying must have filed their income tax for the previous tax year. This year that means, you must have filed your income tax return for 2025 by April 30, 2026. Renewals can be completed online via My Service Canada Account, by phone at 1-833-537-4342, or through the official portal on the internet.

Grey-Bruce Residents Invited To Take Survey Exploring Link Between Childhood Experiences And Health

Grey-Bruce residents can help strengthen public health programs and services in Ontario communities by participating in a pilot project aimed at exploring how childhood experiences affect health and well-being later in life.

Grey Bruce Public Health is collaborating with Public Health Ontario (PHO) on a Community Well-Being Survey.

Survey results will assist PHO and public health units to better understand the link between early life experiences and adult health, so they can design more effective, evidence-informed programs and services that support healthier communities over the long term.

"We are happy to support this Public Health Ontario-led project in Grey-Bruce," says GBPH Physician Consultant Dr. Brittany Graham.

"Grey-Bruce is made up of a diverse population with varied childhood experiences. These are the types of stories public health is hoping to learn from as part of this project. When we get a better understanding of the challenges people face early in life, we can break down barriers to health and build systems that support every person, every family, every community."

Beginning this month, many homes throughout Grey-Bruce will receive a postcard in the mail with a unique passcode and instructions to complete the Community Well-Being Survey online. Households have been randomly selected to receive a postcard, using a Canada Post mailing list, to ensure a fair and representative sample.

The survey is designed to be quick and confidential, taking about 20 minutes to complete.

All responses will be confidential and used solely for research and public health planning. The survey will remain open until Feb. 27, 2026.

Grey-Bruce residents who do not receive a postcard in the mail can still complete the survey by visiting publichealthontario.ca/childhoodsurvey.

Everyone who completes a survey will be entered into a draw for a chance to win 1 of 10 \$100 gift cards.

"At Public Health Ontario, our work is grounded in evidence that reflects the realities of people's lives. By participating in this survey, Grey-Bruce residents are helping to build a clearer picture of how childhood experiences influence adult health. This knowledge will inform more effective, equitable public health programs that support individuals and families now and for years to come," says Michael Sherar, President and CEO, Public Health Ontario.

Ontario Releases 2025–26 Third Quarter Finances

Government remains focused on protecting Ontario by building a more competitive, resilient and self-reliant economy

The Ontario government released the 2025–26 Third Quarter Finances, to provide an update on the province's economic and fiscal outlook since the release of the 2025 Ontario Economic Outlook and Fiscal Review: A Plan to Protect Ontario.

Despite global economic uncertainty, the results reflect the government's responsible path to balance while continuing to make strategic investments to protect workers, support growth and keep costs down for families.

Ontario's real gross domestic product (GDP) increased by 0.5 per cent in the third calendar quarter, supported by gains in net trade. Ontario's real GDP rose by an estimated 1.2 per cent in 2025, and net debt-to-GDP is now projected to be 36.9 per cent, a decrease of 0.8 percentage points. Both of which are stronger than expected at the time of the 2025 Ontario Economic Outlook and Fiscal Review showing Ontario's economic resilience in the face of U.S. tariffs.

As of the 2025–26 Third Quarter Finances, the province's 2025–26 deficit is now projected to be \$13.4 billion, while revenues are also projected to improve to \$223.7 billion, \$0.6 billion higher than expected in the 2025 Ontario Economic Outlook and Fiscal Review.


The government will provide its next update by March 31, 2026 as part of the 2026 Budget.

Fiscal Review.

Interest and debt servicing charges are projected to be \$16.2 billion, consistent with the forecast in the 2025 Budget and 2025 Ontario Economic Outlook and Fiscal Review. Ontario's cost of borrowing for 2025–26 remains unchanged at 4.0 per cent.

The 2025 Ontario Budget included a \$2.0 billion reserve in 2025–26 to protect the fiscal outlook against any unforeseen changes in the province's revenue and expense forecasts, which has been drawn down to \$1.0 billion as part of the current fiscal outlook.


What is being proposed?

This proposal involves rezoning two properties located north and south of Delphi Lane.

The property north of Delphi Lane is currently zoned Development (D) and Hazard (H). It is proposed to be rezoned to Open Space (OS) and Residential One (R1-1-X) Exception Zone to facilitate the construction of a replacement dwelling, as well as an addition to the existing dwelling.

The property south of Delphi Lane is currently zoned Hazard (H) and is proposed to be rezoned to Residential One (R1-1) Zone to allow for the future construction of a dwelling.



Who Can File an Appeal?

Any of the following may appeal the decision to the OLT: the owner, the applicant, a specified person* or public body*, who before the by-law was passed, made oral submissions at a public meeting or written submissions to The Blue Mountains Council. No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

Property Description: Located on the southeast corner of the intersection of the 10th Line and High Bluff Lane, north of and adjacent to the Georgian Trail, a 0.42 acre municipally owned property, known as Roll Number 4242000015008450000, High Bluff Lane, Plan 16M14, Block 27, Town of The Blue Mountains. Statement of Cultural Heritage Value or Interest: the property is considered for designation under Part IV of the Ontario Heritage Act, R.S.O. 1990, c. O.18 as amended, as representing a site of cultural heritage and interest within the Town.

A 152-year-old sugar maple (*Acer saccharum*) located on the above-described property possesses significant cultural heritage value under Ontario Regulation 9/06 due to its historical, aesthetic, and contextual significance

Historical: The tree, estimated to be 152 years old, is a rare and enduring example of the natural heritage of the region, predating significant settlement and development in the area. It represents a living link to the pre-settlement landscape and the ecological history of the region, reflecting the prominence of sugar maples in Ontario's early agricultural and maple syrup production traditions.

Aesthetic: The sugar maple exhibits exceptional visual qualities, with its expansive canopy, vibrant seasonal foliage, and robust form, making it a striking and iconic feature in the landscape. Its aesthetic appeal enhances the scenic quality of the Georgian Trail, a significant recreational corridor.

Contextual: The tree serves as a prominent landmark along the Georgian Trail, a key recreational trail connecting communities and attracting visitors for its natural beauty. Its highly visible location from the public road right-of-way establishes it as a defining element of the local landscape, contributing to the area's sense of place and community identity.

Description of Heritage Attributes: The following attributes embody the cultural heritage value of the sugar maple:

- Its age, approximately 152 years, as determined by measurement, visual assessment and historical photography.
- Its physical form, including its height, trunk diameter, and expansive canopy demonstrate its maturity and health.
- Its vibrant seasonal foliage, showcasing brilliant red, orange, and yellow hues characteristic of the species.
- Its specific location adjacent to the Georgian Trail and near the public road right-of-way, ensuring high visibility and accessibility.
- Its ecological role as a native species, supporting local biodiversity and reflecting the region's natural heritage.


