This month, we are delighted to welcome, Larry Cain, Order of Canada – **a local Olympian athlete and proud winner of Gold & Silver medals in Canoeing in the 1984 Olympics**...our first medals in the sport since, **Berlin, 1936.**

Larry began his career in 1974 at the Oakville Racing Canoe Club, now the Burloak Canoe Club where he coaches High Performance canoeing amongst his other pursuits at his '**Paddle Monster**' company. He competed in three Summer Olympics, winning a **gold medal** in the C-1 500 m (solo paddler) and a **silver medal** in the C1 1000 m events. He also won a **silver medal** in the C-1 1000 m event at the **1989 ICF Canoe Sprint World Championships** in Plovdiv, Bulgaria.

Cain taught Physical Education at St. Mildred's-Lightbourn School, Oakville, until 2014. He then worked as a **coach, preparing paddlers for the 2016 Rio games.**

As part of his presentation today, Larry will offer his thoughts on high performance international sport in today's world, including the influence of media, money and government on athletes and sporting institutions.

8.0 Profiler- Mike Tweetie

In his early days he moved to Cooksville and he studied 'old english'. To increase his income he worked for the "National library of Canada". He became very sick but he decided not to let that get in his way and he took the LSAT test which

allowed him entry to a law school. He became a litigator and retired in 2014 after 40 years as a litigator. He will soon have 4 books in print about law and litigation.

9.0 SPEAKER

This month, we were delighted to welcome Dr. Myriam Nafte who talked to us about forensics and how it is used in crime investigation.

She describes herself as “a visual artist and a skeletal biologist”. She has been in the forensics world for 35 years. She has been involved with reviewing of human remains and has worked as a visual artist often recreating in art human facial structures.

She described the differences between police forensics – i.e. the on site control of all nature of evidence and the lab forensics. Police individuals need 5 years of training before being permitted to control a site. There is physical evidence, testimonial evidence (i.e. witness statements), class evidence (i.e. which needs further review), latent evidence (i.e. finger prints), and indicative evidence. Defense lawyers will always try to have such evidence dismissed as often it is not scientifically based.

One subsequent question re the Sherman murders solicited a comment that certain newspapers often provide inaccurate and poorly researched comments that cause problems for the police

Wolfgang Harman thanked Miriam for a most enjoyable and informative presentation
