Progress Report August 2025

Work continues at our dig site at Ian Avenue and quiet progress is being made. In some respects the location of Trial Trench 2 is very difficult, that is to say finding the archaeology below tons of builder's rubble from the 1963 estate continues to be our biggest challenge, particularly in comparison to the Meadows, where the archaeology of the late Saxon croft cottage found there was conveniently almost directly below the subsoil in some parts of that site.




Trial trench 2 with additional shuttering being constructed

To give an idea of the extent of the collection of rubble, clay and generally bulldozed materials in the trench, here is a provisional context list. For those of you unfamiliar with this, the simple way of thinking about it is as a list of layers, like a cake. We can date the layers of the cake by the finds in them, such as pottery. This is how we have provisionally dated the contexts here: more work will result in more finds and thus more accurate dating.

Sample finds are:

004 Modern post medieval glass C7
005 Sherd of post 1760 transfer printed Blue and White ware C7
006 Sherd of post civil war slip trailed ware C7
007 Sherd of Wirksworth medieval brown slipped oxidised ware C8
008 Rim Sherd of Roman colour coated ware C8
009 Facet of lead moulding or splash C9

As the dig continues more finds will be added from the respective contexts, this helps determine what the contexts are and whether the finds belong there or are intrusive in some way. For example, the contexts of the builders activity in 1963 contain not only materials associated with 1963 such as Marley Tile and food wrappers, but also medieval and Roman items which cannot be from 1963 but are a result of things from the building site being bulldozed together into piles then flattened over the garden.

Work, as they say, continues.
