



PRIME GALVALUME

25 YEAR LIMITED WARRANTY

**JD Metals is pleased to present the following 25 Year Limited Warranty
on Prime Galvalume used as roofing and siding panels**

1. This Warranty applies if any of the following Warranty Conditions occurs:
 - a. For 25 Years after shipment from our manufacturing plant, JD Metals guarantees that roofing and siding panels made with prime Galvalume cold rolled sheet steel, with a coating weight of AZ50 or AZ55, will not, during the Warranty period, rupture, fail structurally, or perforate as a result of corrosion caused by exposure to normal atmospheric conditions.
2. This Warranty does not apply to or cover any rupture, structural failure, or perforation caused by any reason other than corrosion caused by exposure to normal atmospheric conditions. This Warranty also does not apply to secondary (non-prime) Galvalume cold rolled steel sheets, which are sold as-is.
3. JD Metals is not responsible to provide any Warranty Benefits for any damage or condition resulting from circumstances beyond our control, including any of the following:
 - a. Acts of God, falling objects, explosions, fire, external forces or other such similar or dissimilar circumstances beyond our control;
 - b. Harmful fumes or foreign substances in the atmosphere, or salt spray;
 - c. Improper treatment or defects in the substrate metal or in its fabrication or embossing, or any corrosion or loss of adhesion as a result of the embossing process;
 - d. Deterioration or corrosion caused directly or indirectly by contact with fasteners, sealants, and/or concrete/dirt foundations.
 - e. Galvalume finish which has been damaged due to moisture entrapment in bundles during transit or storage, or which have been stored or installed in such a way that allows standing water on the coating;
 - f. Failure or damage resulting from corrosion at cut/bare edges or failure of the metal substrate;
 - g. Galvalume finish that has been stored/installed in such a way that allows contact with animals or animal waste;
 - h. Color or spangle variations between Roofing or Siding panels.
 - i. Where materials / items such as snow guards and solar panels are attached / adhered to the product;
 - j. Steel shavings or minute iron particles from sawing or cutting that come in contact with the painted surface;
 - k. Direct metallic contact or water run-off from dissimilar metals such as, but not limited to, lead and/or copper flashings and other conditions where corrosive fumes or condensates are generated or released inside the building that contains the Galvalume sheet.
 - l. Bends less than 2T for sheet thickness 0.030", bends less than 4T for sheet thickness of 0.031" and thicker.
 - m. Roof slopes flatter than 1/4":12".
 - n. Panel deterioration due to contact with chemically treated or wet lumber.
 - o. Presence of damp insulation and/or other corrosive materials in contact or in close proximity to the panels.
4. No Warranty is provided for Prime Galvalume finish that is subjected to sea spray or installed on property located 1,500 or fewer feet from a salt-water environment.
5. This Warranty applies only to building parts installed on buildings within the Continental United States.
6. This Warranty shall extend to the purchaser of the material and will automatically expire upon any change or transfer of ownership of the property on which the Prime Galvalume finish is originally installed. Should the purchaser become insolvent, bankrupt, or make an assignment for the benefits of its creditors, this Warranty shall forthwith become null and void and of no legal effect.
7. The purchaser must present original sales receipt for Warranty consideration.
8. This is our only Warranty concerning Prime Galvalume finish. Except for this Warranty, WE MAKE NO WARRANTIES, EXPRESS OR IMPLIED, AND DISCLAIM ALL IMPLIED WARRANTIES INCLUDING WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR USE OR FREEDOM FROM PATENT INFRINGEMENT. JD METALS WILL NOT BE LIABLE FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES. We have no other liability with respect to our Prime Galvalume finish, whether based on Warranty, negligence or any other legal theory.
9. **EXCLUSIVE REMEDIES**
Buyer's exclusive remedy and Seller's sole liability for breach of this Limited Warranty shall be limited exclusively to the cost of either repairing non-conforming panels or, at the Seller's sole option, of furnishing sufficient panel product to enable Buyer to replace panels for the non-conforming panels.
10. **LIMITATION OF DAMAGES**
THE LIABILITY OF SELLER SHALL NOT EXTEND TO PERSONAL INJURY, PROPERTY DAMAGE, OR LOSS OF PROFIT, DELAY OR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES RESULTING FROM THE FAILURE OF ANY SHEET TO CONFORM TO THE PROVISIONS OF THIS LIMITED WARRANTY.
