

## 4. THE OSIRIS V/X DISCREPANCY

A critical component of the leak involves the **Osiris V/X** platform. Internal Department of War documents previously classified this craft as "Non-Human Intelligence" (NHI) origin due to its instantaneous acceleration and lack of visible control surfaces.

However, Subject Spears' leaked technical schematics suggest the Osiris V/X is a **proprietary human-built platform** utilizing vacuum-energy propulsion. Spears alleges the government misclassified its own technology as "alien" to evade Congressional oversight and maintain "Off-the-Books" funding.

## 5. THE MCCASLAND-SPEARS-REZA TRIAD

New intelligence has surfaced regarding a long-standing collaboration between **General William McCasland** (USAF, Ret.), **Cory Spears**, and **Monica Reza**.

## 6. LEGISLATIVE PRESSURE AND POLITICAL IMPLICATIONS

## **7. RECOMMENDATIONS**

1. **Immediate Containment:** Execute "Digital Burn" orders on all mirrored sites hosting the F Division missile video.
2. **Surveillance:** Maintain 24/7 technical surveillance on Subject Spears and Monica Reza.
3. **Briefing:** Prepare a specialized rebuttal for Secretary Hegseth regarding the human-origin of the Osiris V/X to mitigate the "NHI" narrative.
