Project: Development of a Framework for Implementation & Monitoring of Triple Elimination and Ending AIDS in Children

Submission Deadline: Monday 08 June, at 4:00pm

Call background and purpose

This Request for Proposal (RFP) invites qualified private consulting firms, public health agencies, and technical assistance providers to submit bids to design, develop, cost, and finalize the Community Systems Strengthening and Intelligence Implementation and Monitoring Framework for Triple Elimination and Ending AIDS in Children. The chosen firm will translate strategic national health goals into an actionable, institutionalized package of operational tools, monitoring systems, and investment frameworks. The primary objective of this consultancy is to build a comprehensive, national-level operational framework centered on closing pediatric health programme gaps through community-driven data, accountability, and targeted investments. The framework focuses explicitly on Triple Elimination (stopping mother-to-child transmission of HIV, Syphilis, and Hepatitis B) and Ending AIDS in Children.

Scope of Work & Core Deliverables

The selected private firm must deliver a fully integrated, stakeholder-validated package comprising:

1. Strategic & Operational Guides

- **National Implementation & Monitoring Guide:** The core strategic vision anchoring community systems strengthening (CSS) to national Triple Elimination targets.
- **Operational Toolkit and SOPs:** Practical, step-by-step Standard Operating Procedures (SOPs) enabling community networks, civil society organizations (CSOs), and partners to execute the strategy smoothly on the ground.

2. Monitoring, Evaluation, & Data Systems

- **Results Framework & Logframe:** A long-term impact roadmap with clear targets, milestones, and strategic outputs.
- **Indicator Reference Section:** A highly technical metadata dictionary defining data collection frequencies, data sources, and calculation formulas for every framework metric.
- **Performance & Intelligence Dashboards:** Conceptual wireframes, data flows, and functional specifications for both a Community Systems Performance Dashboard and a Community Intelligence (Community-Led Monitoring) Dashboard.

3. Organizational Maturity, Risk, & Readiness Tools

- **Maturity Tool & Accreditation Framework:** Standardized criteria and self-assessment tools to evaluate, benchmark, and formally accredit community organizations for health service delivery.
- **Risk Heat Map:** A matrix designed to identify, visualize, and mitigate operational, financial, and environmental risks within community implementation structures.
- **District Readiness Assessment & Index:** A localized diagnostic tool and index scoring system to measure geographic and facility-level preparedness before deploying framework resources.

4. Sustainable Financing, Policy, & Advocacy

- **Policy Brief & National Stakeholder Process:** High-impact engagement collateral tailored to secure buy-in from various sectors

Key Bidding Requirements & Eligibility

Bidding firms must demonstrate strong institutional capacity to manage complex, multi-sectoral public health portfolios. Applications will be evaluated against:

- **Technical Expertise:** Proven track record in public health policy, epidemiological framework design, maternal and child health (MCH), and health economics/costing.
- **Community Systems Knowledge:** Direct experience designing community-led monitoring (CLM) systems and working alongside networks of people living with HIV (PLHIV) and civil society.
- **Stakeholder Consensus Building:** Ability to manage complex national consultations, incorporating feedback from government bodies, technical working groups, and grassroots community actors.
