The Camano Law Enforcement Support Foundation operates as a 501.c.3 non-profit charitable organization to raise funds. It uses the funds to help Island residents by supporting financially sustainable programs and activities for the Island County Deputies and the State Park Rangers. Consistent with its Mission, it also provides education to citizens in safety, security as well community outreach programs.

SOME OF THE ITEMS PURCHASED BY C.L.E.S.F.

1. A gun safe for the Camano Sheriff's Precinct.
2. Overtook the purchasing of uniforms for the Camano Citizen Patrol volunteers from the Sheriff's Office.
3. A portable radar speed indicator (radar unit) for the park Rangers in 2012.
4. A radar trailer for the Camano Sheriff's East Precinct in 2014, which is used by the volunteers to place on the public and private streets (upon request only).
5. Two portable police radios, one as a backup for the Camano Sheriff Precinct, and the other given to the Camano State Park Rangers.
6. A metal detector for the deputies and park rangers in 2015.
7. Purchase of 4 "trail cameras" for deputies and park rangers to "catch garbage dumpers, and thieves".
8. A State approved breathalyzer for Camano Park Rangers.
9. Christmas "Shop with a Cop" program started in 2017 for the needy students from two elementary schools and continued each year.
10. Sponsored free basic handgun safety classes, and female self-defense classes, and forums on anti-human trafficking as well as on Cybersecurity and identity theft protection for seniors.
11. Safety Vests to support "be visible be safe" program – we have purchased and handed out hundreds of vests to date. The vests are handed out to biking and walking citizens (free) by deputies and Citizen Patrol.
12. Money was provided to Deputies and to Rangers in the form of Cash Cards to help Camano residents in need or in distress.
13. Easy Long Reach Grabber with Air Wedge tool kits to deputies and rangers.
14. In 2021 CLESF donated to the Sheriff's office to purchase a second Speed trailer and provided a 1-gallon Makita air compressor to the Camano deputies; and the Foundation donated an HP laptop computer and a radar gun, and a shot clock to State Park rangers.
15. Viking booster kit (jump starting cars) for SCP 740.
16. In 2023, the Foundation purchased six new chairs to replace their broken chairs.
17. Acquired 13 med bags (special Ops Military Grade Field Medical Pack 10 for deputies and 3 for rangers. It will allow them to give first aid to victims of not only automobile accidents ranging from cuts and bruises to more severe lifesaving aid as well as incidents encountered during calls of service.

The Board of Directors and Members greatly value the generosity of the Camano businesses and individuals for their support and donations to help our law enforcement agencies.
