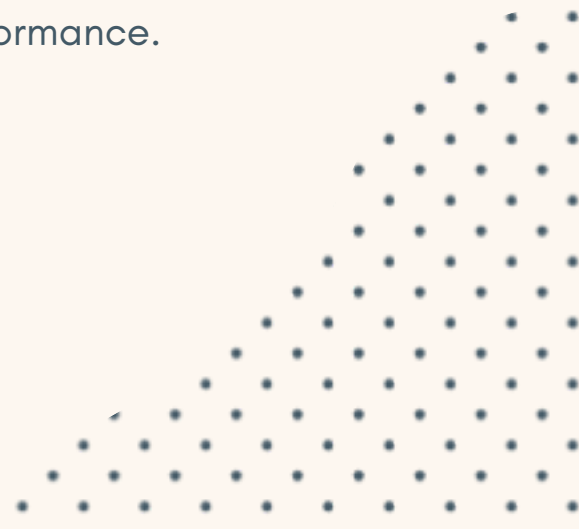
Présentation

- Continually improving its processes, health, safety performance results, and customer satisfaction, with a management system designed to establish goals and assess performance.
