


Lost at Sea: How a 1666 Law Declared You Dead (and How to Reclaim Your Life)

So, the Act declared that if a person stayed "beyond the seas" or disappeared for seven years without proof of being alive, they were legally dead.

But here is the kicker: the state took custody of everyone's property and rights into a trust. They became the "Trustee," holding your titles until the "living man" returns to reclaim them.



ADMIRALTY LAW: WHY YOU ARE A SHIP AT DOCK

The system doesn't operate on the "Law of the Land." It operates on **Admiralty Law**: the Law of the Sea. This is the law of commerce and international trade. Under this system, you are not a man or woman; you are a "vessel."

Think about the language they use. It's not an accident.

- **BIRTH vs. BERTH**: When a ship pulls into a port, it is given a "berth" certificate. When you were born, you were given a "birth" certificate.
- **BIRTH CANAL**: Your mother has a birth canal, just like a ship navigating a waterway.
- **DELIVERY**: The doctor "delivers" the baby, just like a captain delivers cargo.

When your parents signed that birth certificate, they unknowingly registered a new vessel in the sea of commerce. They informed the government there was a "new ship in town," and the government issued a title to that ship. That title is your **STRAWMAN**.

THE ALL-CAPS NAME: YOUR LEGAL FICTION

Look at your driver's license, your passport, or a court summons. Notice anything? Your name is in **ALL CAPITAL LETTERS**.

In the world of law, capitalization matters. In English grammar, a name in upper and lower case refers to a living, breathing human being. However, in legal terms, **ALL CAPS** always refers to a **LEGAL ENTITY, FICTION, COMPANY, or CORPORATION**.

- **John Doe**: The living man.

- **JOHN DOE:** The corporate fiction (The Cestui Que Trust).

The government created this fiction to interact with you in commerce. A living man cannot be "sued" in a corporate court, but a corporation can. By using the ALL CAPS name, they trick you into accepting the liability for the trust. You are the "Surety" for the dead entity. You are paying the bills for a ghost.



THE COURTROOM GAME: WHO'S WHO?

When you walk into a courtroom, you aren't walking into a place of justice. You are walking into a bank. It's a game of trust law, and if you don't know the roles, you lose by default.

- 1. THE CLERK (The Real Power)** The Clerk of the Court is the Trustee for the Cestui Que Vie trust owned by the state. They are the ones who appoint the other actors.
- 2. THE JUDGE (The Administrator/Trustee)** In that specific "constructive trust" (the case), the judge acts as the Trustee. Their job is to manage the accounting. When they ask "State your name," they are asking you to identify as the ALL CAPS name. If you do, you accept the role of Trustee: the one liable for the debt.
- 3. THE PROSECUTOR (The Executor)** The Prosecutor is the Executor. They brought the claim. In trust law, whoever creates the controversy holds the liability. This is why prosecutors are so desperate to get you to "plea." A plea is an agreement to take the liability.

4. YOU (The Beneficiary) You are supposed to be the Beneficiary of the trust. But the system has flipped the script. They want to be the beneficiaries of your labor and energy, so they trick you into becoming the Trustee/Debtor.

THE SUBROGATION OF RIGHTS

Since 1666, your rights have been subrogated. This means the state has stepped into your shoes. Because you are "legally dead," you need "representation" (an attorney). A dead person can't speak, so the attorney (who is an officer of the court) speaks for the "estate."

The word "Attorney" comes from "attorn," which means to turn over. When you hire an attorney, you are "attorning" (turning over) your property and rights to the state. This is why you should never voluntarily go to court as a "Defendant."

HOW TO RECLAIM YOUR AUTHORITY

You don't have to stay "lost at sea." You can reclaim your titles and move from "Debtor" to "Creditor."

1. RECLAIM THE STRAWMAN Use UCC-1 filings to put a lien on your ALL CAPS name. This establishes that YOU are the secured party and the primary creditor of that legal fiction. You are capturing the entity the Crown created and bringing it under your control.

2. CORRECT THE ERROR You must rescind your signatures on "slave documents" *nunc pro tunc* (retroactive to the signing date). This includes appearance bonds, motions, and adhesion contracts. You are informing the system that those signatures were obtained without full disclosure of the risks and responsibilities.

3. ACT AS THE CREDITOR Stop begging for "justice" from a system designed to extract your energy. Issue orders. If you are the beneficiary of the trust, you have the authority to direct the Trustee (the judge) to settle the account.

4. KNOW WHO YOU ARE You are a living man or woman on the land. You are not a vessel, a ship, or a corporation. Once you stop acting like a dead entity, the "Admiralty" jurisdiction loses its grip on you.



THE BANKRUPTCY REALITY

Everything in the public is operating in bankruptcy. Since WWI, money hasn't been backed by gold or silver: it's backed by your labor. You are the "gold" in the vault. The government issues bonds against your future labor.

When you get a court summons or a bill, it's an invitation to settle a debt in a bankrupt system. If you fight it (plead "not guilty"), you create controversy and become liable. If you **Accept for Value (AFV)** and return the document for full credit, you are acting as the creditor who settles the account.
