

The Ambassador's Shield: Using Your Baptismal Record to Exit the Corporate Matrix

They operate under a **private lien** that they didn't even know existed, where the state has a claim on their labor and property. To stop this, you must understand your status. You must learn **how to become a trustee** of your own estate rather than a servant to the public debt.



THE BAPTISMAL RECORD: THE LIVING ENTITY VS. THE STATE CERTIFICATE

STOP CONFUSING DOCUMENTS. Use the right record for the right jurisdiction.

1. **BIRTH CERTIFICATE = STATE CORPORATION (PUBLIC SIDE).** It's a title document for a corporate franchise issued by a State. It's paper for a **PERSON** (legal fiction).
2. **BAPTISMAL RECORD = LIVING ENTITY (ECCLESIA/EMPIRE SIDE).** It's a status record for the **PEOPLE** (living). It's your "in-house" record in the Church/Empire channel.

RE-BIRTH VS. RE-BOOT (B-E-R-T-H).

- **RE-BIRTH** = standing "on the soil" as living.
- **RE-BOOT / B-E-R-T-H** = you were "loaded" into a system as cargo "at sea" (commercial jurisdiction), unless you correct the record and declare where you stand.

PEOPLE VS. PERSONS. DOMICILE VS. RESIDENT.

- **People** = living men/women (substance).
- **Persons** = corporate fictions (paper).
- **Domicile** = where the living stand (home/soil).
- **Resident** = an office-holder role inside a corporation (public employment footprint).

LOCK IT IN WITH ESTOPPEL BY DEED.

Your primary "stop-the-fiction" weapon is **Estoppel by Deed** over the baptismal record: you put the world on notice that (1) the living is the principal record, and (2) the corporate franchise is not the source of identity. That forces the opposition to either rebut with competent evidence or stand down.

SET-OFFS + RELEASES: USE THE ROMAN TREASURER CHANNEL

STOP BEGGING BANKS. START DEMANDING ACCOUNTING.

In this model, the play is **set-off** and **release**, not "payment" as a debtor.

TACTICAL LEVER: SECRETARY OF THE TREASURY (PUERTO RICO) = "ROMAN TREASURER."

Use the idea of the Treasury (and the Puerto Rico seat) as the **treasurer function**: the office that can authorize releases, apply set-offs, and process entitlement-style transfers once status and record are asserted correctly.
