

THE GREAT SECRET: MEET YOUR STRAWMAN

WHAT IS A "STRAWMAN"? (THE REAL YOU VS. THE PAPER VERSION)

In the world of law and linguistics, writing a name in all caps signifies a "capitis diminutio maxima", a maximal loss of status. It represents a corporation or a dead entity, not a living man or woman.



When you walk into a courtroom or a bank and identify yourself as that all-caps name, you are "joining" yourself to that paper fiction. You are telling the system, "Yes, I am that corporate entity," and by doing so, you agree to take on all its debts and regulations.

THE BIRTH CERTIFICATE TRAP: REGISTRATION AS A CONTRACT

Don Kilam teaches that the "trap" is set the moment your parents register your birth. Most parents do this out of a sense of duty, not realizing they are entering into a high-stakes contract with the state.

1. **Registration vs. Recording:** When you "register" something, you are giving up legal title to it. If you register a car, the state holds the title, and you get a "certificate of title" to use it. The same happens with a baby.
2. **Ownership:** By signing that birth registration, parents unknowingly pass the "legal title" of the child over to the local authority. The state then creates a "Birth Certificate," which is actually a security instrument, a bond.
3. **The Secret Name:** The birth certificate isn't "you." It is the birth of the Strawman. It is a title to a fictional entity that the state owns and manages. They then allow you to "use" this entity to interact with their system, to get a job, open a bank account, or apply for "benefits."

This is why the system feels so heavy. You aren't operating as a free man or woman; you are operating as an unpaid trustee for a corporate entity that the government created.



LEGAL VS. LAWFUL: THE MONEY AND CONTROL RACKET

Don Kilam emphasizes a crucial distinction that they never taught you in school: the difference between what is **Legal** and what is **Lawful**.

- **Lawful:** This refers to the Law of the Land, Common Law, and the laws of the Creator. It's based on simple, common-sense rules: Don't hurt anyone, don't steal, and keep your contracts. This is where the living man resides.
- **Legal:** This refers to the Law of the Sea (Admiralty/Maritime) and the world of statutes, codes, and regulations. It is "Public Policy."

The reason this "paper you" was created is simple: **Money and Control**. Statutes, like paying certain taxes, license fees, or minor fines, are written for the *Strawman*, not the living human. The Strawman is a creature of the state, so the state has the right to regulate it.

If you don't realize you are separate from your Strawman, you will feel forced to pay for things that are actually optional for a living soul on the land. You become "surety" for the Strawman's debts. This is how the "Corporate Matrix" keeps you in a cycle of perpetual debt. But once you understand this, you can start to use a **Private Administrative Process** to move back to the private side where you belong.

LEGALESE: THE LANGUAGE OF DECEPTION

Have you ever wondered why lawyers and judges sound like they're speaking English, but somehow you still don't understand what's happening? That's because they are using "**Legalese**", the secret language of the bar.



One of the most dangerous phrases in a courtroom is: "**Do you understand?**"

In normal English, this means "Do you know what I'm saying?" But in Legalese, Don Kilam reveals it means "**Do you stand under my authority?**" By saying "yes," you are accidentally granting the judge jurisdiction over you. You are agreeing to "stand under" their statutes and rules.

PROTECTION: PRIVATE ADMINISTRATIVE PROCESSES AND STATUS CORRECTION

So, how do you fix it? You can't just yell "I am a living man" in a courtroom and expect results. That's not how the game works. You have to use their own rules against them through **Status Correction**.

The first step to freedom is **knowledge**. Don Kilam and DK's Private Business Circle teach students how to move from being a "debtor" in the public to a "creditor" in the private.
