# 1. CALL TO ORDER

• PW called the meeting to order at 10:04 AM

#### 2. ROLL CALL

#### 3. AGENDA & ORDER OF BUSINESS

• PW moved acceptance of the agenda. Second by SE and approved unanimously.

#### 4. MEETING MINUTES

• PW moved to approve the Board Minutes from the last meeting, but EDJ suggested to move the meeting minutes to the last item of the day in closed session.

#### 6. AGENCY/PARTNER REPORTS

No partners in attendance

#### 7. REPORT OF THE FINANCE COMMITTEE - Susan Williams

- FJS reported that we are still waiting for ERC funds. It doesn't look like we'll be getting it soon as IRS dept is still working their way through returns.
- Back Federal payroll taxes are owed and the IRS is willing to work with us.
- Audits are on hold due to documents we need still are being held at the DA's office.
- Cal-OES and FEMA reimbursements. The process is not easy to navigate as they want considerable
  detail on how exactly we spend project time. They say that they want us to succeed but continue to
  ask for more notes on the project.

#### 8. REPORT OF THE CHAIRMAN OF THE BOARD - Pete Williams

- No FireWise Community Festival this year.
- SE explained that the amount of work involved in putting on the festival is too great for the amount of funding netted for FWC's.
- SE said that Jamie and Pete, with great help from Brian Swagerty, finished up writing the Community Wildfire Defense Grant (CWDG) for FWC's and got it sent in on time. If we get the award, we will hire personnel to manage the program.
- It may take a while to find out if the grant application is successful. EDJ said it can take up to 9 months for the first round and up to a year for the second round for federal funding to come in.

- EDJ explained the difference between the Coalition's and the FSC's roles in our community. FSC is the reginal coordinator for FWC's and we have helped establish over 100 communities. The Coalition of FWC is an educational group of leaders and participants from those communities. The Coalition steering members decided not to support our CWDG grant application, but we received over 30 letters of support from FireWise communities.
- PW- Our mission is to support those communities; we now have 110 FireWise Communities and many more are waiting to become certified. Finding ways to support them through this grant is the right way to go. AD explained that FWCs need support to help them complete the required the Risk Assessment.
- PW introduced Jeff McEvoy who has expressed interest in possibly joining our board.

## 9. REPORT FROM THE EXECUTIVE DIRECTOR – Jamie Jones

- Grant update: we have already received feedback from FEMA, Cal-OES and Hagerty consultants on the BRIC grant that we are partnering with the City of Grass Valley, submitted in early February. The grant is for a total of \$44 million. There is a match component included that the City of Grass Valley is primarily providing as part of the residents Home Hardening reimbursement program.
- As mentioned, the CWDG has been submitted. We are still waiting to hear back on the Forest Health grant that we submitted in January. We are working on a PG&E funding opportunity that will help fund the chipping program.
- With our decreased staff size, we have decided that our office is too large of a facility for us and we have decided that a smaller office space is more financially prudent. We have acquired a small store front office in Nevada City at 590 Searls Suite #4. With the Spring Hill property owners' consent, we could potentially return to the larger space if our staff grows.
- Status documents held by the DA's office: We were told that we would be provided copies of all of our documents on a thumb drive. When our attorney went to pick them up, the thumb drive contained less than a quarter of the documents taken--- not enough to complete audits or close out Cal-Fire grants. The DA's office said that they haven't been able to scan all of the documents taken from our office in October that and more copies of the documents will be coming at a different time.
- EDJ was invited to attend a meeting regarding the County of Nevada's Climate Action and Adaptation Plan. It is required for consultants to complete County plans like LHMP, CWPP, and CAAP. These are all planned documents that allow the community to access funding. Basically, it's mitigation and resiliency efforts when it comes to storm and fire related issues, i.e. how do we make changes and how do we adapt. EDJ will be serving on that team for 18 months with 30 peers.

# 10. REPORT FROM THE DIRECTOR OF OPERATIONS

- We are taking a detour with SRCC continuing to clear the BLM land near Ponderosa site due to environmental concerns with rare plants and animals. It is a little bit more complicated than originally thought but we now have decided to reroute that project and work on the Alta Sierra BLM parcel.
- OCW has been helping EDJ with grant writing proposal and grant close outs. Operationally, not a ton going on-- it's more administrative right now.
- The portion of BLM near the Ponderosa site that the County was responsible for did get the environmental completed. Because of how long it's been, parcels will need complete retreatment not just maintenance to be in compliance.

## 6. AGENCY/PARTNER REPORTS

• Jorge from BLM added that they are currently working with FSC and SRCC on Alta Sierra / Ponderosa sites, said that BLM and SRCC might be able to lend out a chipper for that project and wants to talk to OCW at a later date.

# 7. REPORT OF THE FINANCE COMMITTEE - Susan Williams

- SW reported that we are still waiting for Employee Retention Credit (ERC) funds, hoping for it to show up in the mail soon.
- We made the IRS 2025 first quarterly employment tax payment.
- Audits—There is no update at this time as we need funding to continue with audits. Further, the DA's
  office still has vital information needed to complete the audits. Janet has done all the audit prep up
  to 2023.
- We have moved from our large Springhill office to a smaller, less expensive one at 590 Searls Ave. in Nevada City, saving money on rent and utilities. As the Springhill lease term is through January 2026, would like to sublease Springhill offices if possible.

# 8. REPORT OF THE CHAIRMAN OF THE BOARD - Pete Williams

- SE reported that we successfully submitted the CWDG grant application for \$7.8M; we will likely hear about status by late Summer.
  - This grant will help out the FireWise communities with defensible space and ingress and egress along evacuation routes.

# Staff:

- The grant will fund a program manager with an administrative assistant to manage meetings and a licensed professional forester to work with the FireWise communities.
- The grant will fund green waste events within the communities and help with the development of materials that DSAVs can use to help advise homeowners.
- A committee will be formed to develop guidelines for how the money will be distributed to FWCs.
- PW reported that we have a small group of Defensible Space advisors that have come together to improve the DSAV process and update/create a better DSAV form.
- PW reported that the newly formed non-profit Fire Safe Nevada County Coalition (FSNCC), an outgrowth of the Firewise Coalition, will be further reaching out to FWCs to provide services along with the education that they have provided for many years.

# 9. REPORT FROM THE EXECUTIVE DIRECTOR – Jamie Jones

- The organization's update: our finances have been a lead conversational topic
- The Grant update goes hand in hand with the finance update. EDJ has been in contact with Cal OES regarding our FEMA project reimbursements. We are still waiting for reimbursements for the 4<sup>th</sup> Quarter 2024 for work done on the Home Hardening retrofit program and the Deer Creek Canyon Shaded Fuel Break Project. We resubmitted the reimbursement package and Cal OES should be reviewing it this week.
- More Grants: CWDG has been submitted. The Forest Health extension project in partnership with the Forest Service, submitted in January, is still under review. However, this round of funding might be allocated to higher priority projects this fiscal year. If more funding opportunities open up, we will be applying for the Ponderosa extension project. We applied to the PG&E foundation for another round of chipping and green waste funding for this fiscal year. The BRIC program has been defunded. We are working with FEMA to migrate the BRIC grant and split it into 3 separate programs within the HMGP partnering with City of Grass Valley. Lots of grants in the queue and we're waiting to hear back.
- SRCC update: They chose Ponderosa West BLM parcels to be their priority unit; surveys still need to be done, and funding is tied to those parcels. Also submitted for PIN Project Initiation Notice to complete the 32 acres of parcels in Alta Sierra and we are hopeful to start work on those parcels this season.
- DA update: We still haven't received any additional items back from the DA and are still waiting for communication from our attorney about information on the second search warrant to look at our devices. No word yet. Without those documents, we are unable to complete our audits that are our obligation and legal requirement as a 501(C-3) non-profit. It is also inhibiting us from being in compliance with our funders that we have good standing partnerships with but without those documents we are unable to close out those contracts.

#### 10. REPORT FROM THE DIRECTOR OF OPERATIONS

#### 11. DIRECTORS COMMENTS -

- SE sounds like the green waste event in Alta Sierra was very successful.
- AD we added another FWC last week named 'Bitney Corner'; and 3 more are very close to completion. We now have 113 recognized FWCs.
