1.	One (1) completed and signed visa application form duly filled in legibly, in English. 用英文清晰填写的一份完整的并已经签字的签证申请表原件			
2.	Two (2) passport-size photographs on a white background which must be no older than 6 months. 两张白底证件照规格的近照（近 6 个月内拍摄的近照）			
3.	Original and one (1) photocopy of passport (only pages with visa stickers or stamps need to be copied, as well as the passport's extension date if applicable). 护照原件及一份复印件（复印所有签证页但空白页不需要复印，如有延期页，须提供延期页复印件）			
4.	The applicant's passport should be valid for at least three (3) months after the date of the expiry of the visa and with at least 6 months remaining from the date of departure from China. It should contain at least 2 blank pages. 护照有效期至少到截止有效期后的3个月并且从中国离境日期后至少有 6 个月的有效期限。要求至少仍保留 2 页空白页。			
5.	Documentation on former travels abroad should be provided if available e.g. former passport(s) with all pages attached. 能显示以前出国旅行的信息证件（如有的话）；如旧护照原件			
6.	One (1) copy of the family book with every page included. 户口本一份全本复印件。（只针对中国公民）			
7.	Proof of a valid travel medical insurance policy, with a minimum coverage of 30,000 Euro. The policy must be valid throughout the Schengen area and cover the entire period of the applicant's stay. The applicant is required to submit both the English and the Chinese version of the insurance policy. 覆盖整个行程的人身意外医疗旅游保险，要求最低保额在 3 万欧元人民币以上,包含整个行程并在所有申根地区有效。此份保险须为中英文版本。			
8.	A confirmed two-way air ticket reservation issued by an airline or authorized travel agency. The ticket should only be bought after the visa has been issued. When applying for a multiple-entry visa please provide the reservation for the first entry. 往返机票订单, 可以来自航空公司或者旅行社。申请人应于签证签发后, 出票付款。若申请多次入境签证, 需提供首次行程的往返机票订单。			
9.	Proof of accommodation for the whole duration of the intended stay. 整个行程的住宿证明。

12.	<p>Original financial guarantee by the sponsor:</p> <p>If the sponsor resides in Malta, proof of a regular income over the last 3 months and a notarized Declaration of Proof form and supporting documents need to be presented. 13.	<p>Proof of solvency of the applicant: Bank statements, in original, with the bank's stamp for the last 3 to 6 months, no deposits.</p> <p>For employees: a copy of the business license of the applicant's employing company with the original stamp of the company, a letter from the employer (in English, or in Chinese with English translation) on official company letterhead with stamp, signature, date and clearly mentioning: the address, telephone and fax numbers of the employing company, the name and position in the employing company of the countersigning officer, the name of the applicant, the applicant's position, salary and years of service and approval for leave or absence.</p> <p>For retired persons: Proof of pension or other regular income.</p> <p>For unemployed adults: If married: Letter of employment and income of the spouse and a notarized certificate of marriage, legalized by MFA, If single/divorced/widow/widower: any other proof of regular income.</p> <p>申请人偿付能力证明: 最近 3 到 6 个月的银行对账单, 无需存款证明。</p> <p>在职人员: 盖章的公司营业执照复印件, 由雇主出具的证明信(英文文件, 或者中文件附上英文翻译), 需使用公司正式的信头纸并加盖公章, 签字, 并明确日期及如下信息: 任职公司的地址、电话和传真号码, 任职公司签字人员的姓名和职务, 申请人姓名、职务、收入和工作年限, 确认允许休假;</p> <p>退休人员: 养老金或其他固定收入证明;</p>			<p>The applicant can submit either item 12 or item 13 as the financial means.</p> <p>12 和 13 项可选其一提交。</p>

14.	<p>For minors (under 18): Student card and an original letter of the school, mentioning the full address and telephone number of the school and granting permission for the student's absence. The name and position of the person giving the permission should also be included.</p> <p>Minors travelling alone or with one parent: notarized certificate of permission to travel from both parents, or legal guardians (when the minor is travelling alone) or the parent or legal guardian not travelling (if the minor is travelling with one parent), legalized by MFA. 15.	<p>NON-CHINESE CITIZEN:</p> <p>Chinese visa or residence permit valid for 3 months after return.</p> <p>非中国人:</p> <p>有效期在返回时间 3 个月后的中国签证或者居留许可证</p>			

Please note that the Embassy of Malta may in justified cases, request additional documents which are not mentioned in the above list; or an interview during the examination of an application. The applicant is hereby informed that submitting the above-mentioned documents does not guarantee automatic issuance of a visa. It is also important to note that original certificates submitted with applications may not in all case be returned.
