## **General Maintenance Procedures**

### 1. Lawn Maintenance

- Lawn maintenance includes mowing of all grassy areas; edging along sidewalks, driveways, parking areas, and flower beds; string trimming all grassy areas unreachable by mower; weed control in all flower beds; blowing off all clippings and other debris from paved surfaces and decks; blowing all breezeways; blowing leaves off lawn and parking areas and collecting or mulching as needed.

## 2. Trimmino

- Plants: A continuous program of trimming will be performed to all shrubs and ground covers. Plants will be trimmed to promote flower development, foliage growth and maintain shape.
- Palm Trees: Palms up to 19 feet will be trimmed as needed and seed pods will be cleaned out once a year.
- Trees: To enhance their natural appearance, small trees will be maintained to a height of 10 feet. Additional work required above 12 feet will be treated as an extra charge. Large limbs or trees that fall and cannot be carried away by one man will be considered extra work. Extra work will be performed upon agreement between Simply Green Landscaping, LLC and Indigo Fields HOA.

### 3. Litter Clean Up

- Roadways, walkways and parking areas as will be blown clean as needed.
- All trash and debris will be removed and properly disposed.

# 4. Watering

- Valening
   Setting irrigation system (if present) for winter and summer operation if controller is available.
- Repair Irrigation parts damaged by Simply Green Landscaping, LLC personnel.
- Irrigation adjustments requiring more than 1 hour will be billed at \$85.00 per hour plus the cost of materials. Repairs requiring less than one man-hour will be billed for parts only.

### 5. Storm Damage

- Damage from hurricanes, lighting or any other extreme weather conditions (also known as Acts of God) will not be the responsibility of Simply Green Landscaping, LLC.

## **Scheduled Service Frequency**

March - October - weekly service November - February service every other week. (Approximately 38 total visits annually)

## **Additional Services Upon Request**

Annual Plants - \$85 per flat Long Needle Pine Straw - \$6.85 per bale - **Quantity needed for property:** Mulch - \$70 per cubic yard - **Quantity needed for property:** Storm Cleanup - \$450 per man per 8 hour day

#### Miscellaneous Services

Maintenance supplies and equipment will be provided by Simply Green Landscaping, LLC.

Simply Green Landscaping, LLC will report any repairs or maintenance items needed that are not our responsibility such as burned out lights, dead trees or shrubs etc.

Annual plantings will be installed upon request and charged at time of installation (\$65 per flat).

Long needle pine straw and mulch will be added upon request (\$6.85 per bale, or \$70 per cubic yard of mulch).
