Definition:

The Board of Assessors (BOA) are elected by the Town's registered voters to serve three-year terms. The Board of Assessors are charged with valuing property at the full and fair cash value in accordance with state guidelines under the direction of the Massachusetts Department of Revenue.

Board:

The Board of Assessors met every other Wednesday coinciding with the meetings of the Board of Selectmen. Meetings are held at 5pm. Board Members are Seth Bean, Chair, reelected May 2018; Krista Bishop; and Melanie Medon. Krista Bishop has also successfully taken on the role of Assessors' Clerk.

Notable items from Fiscal Year 2018:

During Fiscal Year (FY) 2018 the BOA completed the mandatory five-year certification of values by the Massachusetts Department of Revenue. This means that the towns assessed values represented full and fair cash value for taxation and was certified as such by the Department of Revenue. FY2018 was the first year of five-year certification cycles, having previously mandated three-year certification cycles, recognizing the difficulties for both large municipalities and small towns to recertify all values in three years.

As part of the five-year recertification process, Florida, along with the towns of Rowe and Monroe, hired MR Valuations to assess the Hydroelectric facilities of Bear swamp and Fife Brook, and Sherman Damn and Deerfield #5. MR Valuations found that the valuations of these properties declined with the use of the Cost and Income valuation models. The reduction in the valuation of these properties caused a shift of more tax burden on the Residential property segment. Rowe, Florida, and Monroe have agreed to begin more frequent valuations of these properties to ensure the proper valuation is in use, and to ensure the Market valuation model is considered in the valuation of these facilities.

Tax Rate:

The FY 2018 Residential Tax Rate was \$10.30 per \$1000 of assessed value, and the Industrial, Commercial and Personal Property Rate was \$29.97 per \$1000 of assessed value. This rate was determined by dividing the tax levy, \$2,418,800 by the total assessed value of all taxable Real and Personal property. The following is a summary of where the revenues for the Town of Florida originated.

TAX LEVY LIMIT

The levy limit is maximum amount of revenue a community can raise through real and personal property taxes. The levy limit changes every year based on a formula in the law. The following events result in permanent increases to the levy limit: an automatic 2 1/2 % increase, new growth, and voter approved overrides. The levy limit can also be increased by debt exclusions and capital outlay expenditures, however, neither of these results in permanent increases. The following is the Town of Florida's FY 2018 levy limit:

Florida Council on Aging Florida Senior Center Annual Report, July 1, 2017- June 30, 2018

The Florida Council on Aging, appointed by the Board of Selectmen, serves to assess the needs of Florida residents, ages 60 and older, with the goal of assisting them in continuing to lead independent, meaningful, and dignified lives in their homes and the community.

According to a March 21, 2018 report entitled "Town of Florida Residents' Age List From 01/01/1900 to 12/31/1958", the Town has 236 residents age 60 and older, with the oldest resident being aged 86, having a birth year of 1922. More than half are between the ages of 60-69, approximately 25% of these residents are between the ages of 70-79 and approximately 13% are between the ages of 80-86.

ATTENDANCE

A total of 12,418 individuals signed in over a prior nine-year period to participate in our programs, for an average of 69 individuals each month in that prior nine-year period. (This is called a duplicate count.) Efforts have been successful to increase attendance at the Senior Center. For totals of the current year, a total of 958 individuals signed in over an 11-month period from 7/1/2017 through 5/31/2018 for an average of 87 individuals each month.

During the current year we welcomed seniors from Northern Berkshire area towns including the towns of Adams, North Adams, Clarksburg, Savoy, Cheshire, Williamstown, Monroe, Rowe, Windsor, and communities in New York, Connecticut, and Vermont in keeping with the federal mandate that senior centers are open to any senior, regardless of residence. An average of 15 educational / cultural / special events were held and presented each month. In keeping with the mission to provide activities, programs and services, the following categories were included during the current fiscal year:

weekly exercise, weekly game days, an 8 week fall prevention program (presented twice), special music history programs, a Veterans Benefits program, monthly special luncheon programs, a CPR program, a First Aid program, a foot clinic every other month, a Pastel Painting program, a program presenting a History on the Town of Florida, a storytelling and folklore program, an Assistive Technology program, computer trainings, financial fraud programs, a Medicare fraud program, an identity theft program, an annual Saint Patrick's Day program, an annual Christmas Party, an annual Easter program, and monthly Social Hours programs. Beginning in May, a twice a week program is offered to residents and employees of the Town of Florida to affect the use of the fully equipped Fitness Center that is in the lower level of the Senior Center.

SERVICES

A summary of other services provided in the current year include:

- 1. An average of 20 lunch meals each month were prepared and served.
- 2. 10 Brown Bags of food items were distributed each month through the Western Mass Food Bank Program.

Select Board Report July 1, 2017 To June 30, 2018

This past year brought about many changes to the Town of Florida.

The small bridge project funded by Mass DOT that reconstructed the bridge over Cold River on South County Road was completed in the fall. The final inspection from the state took place once the snow melted in the spring of 2018.

Blackstone and Stryker Roads were paved for the first time. This brought about issues of speeding and increased through traffic on these side roads.

After a total of 20 years serving the Town of Florida as a selectman, Richard LeClair did not seek reelection. Ericka Oleson was voted in on May 7th joining Neil Oleson and Krista Bishop. The select board reappointed Neil as chairperson.

As the Last Mile Program progressed, discussion with numerous broadband companies and the Massachusetts Broadband Institute (MBI) were frequent throughout the year as Florida searched for a broadband option. Through the guidance of the MBI, Florida joined with Hawley, Savoy, and Monroe on the search for a broadband option that would best fit the needs of the four towns. The four towns chose to move forward into FY19 with WiValley who would provide wireless internet to the residents of the town.

With recreational marijuana being legal in the state of Massachusetts, the town voted to pass a marijuana moratorium at the annual town meeting on June 8th. This would allow the town one year to decide on any zoning changes or bylaws in regards to recreational marijuana businesses.
