Selectboard:

- Mike reported he contacted the person regarding the Windmills about the road damage done to Tilda Hill Road. They will be fixing the road in the last week of August. Mike informed them if it doesn't happen the town will fix it and send them the bill.

Jim White, Highway Department Supervisor:

- Jim presented each board member a binder with the responses to the OSHA violations. Violations reviewed with Jordan. Corrections due to OSHA August 27, 2024. Some training was part of the violations. Jim has signed himself and the highway crew up for Chainsaw Training and Slips, Falls and Trips. Workplace safety notice to be published in all town areas, Garage, Senior Center, School. Chemical list posted in Jim's office. The guys have reviewed the forms and know how to review the binder when working with any w. Employee Incident Report Sheet created.
- Tighe and Bond, working with New England Power, will be coming up in the next 2 years to start working on the main power lines out of North Adams, into Florida and Monroe.
- Waiting for All State to chip seal. They have had several rain delays.
- Rough quote to do Whitcomb Hill Road from Warner Brothers is \$5.7 million. This does not include line painting, police detail, permits, signage or tree work. Representative Barrett will be attending the Selectboard meeting scheduled for September 25, 2024, to discuss this.
