#### 6. Old/New Business

- The Core Service Standards for Oral Health Care will be emailed to members for review prior to the next scheduled meeting on April 11, 2019
- A Training Presentation was held during meeting sponsored by Gilead Sciences. The
  presentation was given by Dr. Felipe Arias, an Infectious Disease Specialist from Philadelphia.
  Dr. Arias spoke about the correlation between the opioid epidemic and the spread of Hepatitis
  C via Intravenous Drug Use as well as the potential risk of undiagnosed HIV among these
  populations. Dr. Arias emphasized the need for a strategy to reduce the spread of Hepatitis
  through screening, treatment, prevention and risk reduction of Hepatitis C.
- There were two persons nominated for the Vice-Chair position: 1) Vieshia Morales and 2)
  Richlyn Burnham. Prior to the next meeting, members will vote by email and the new Vice
  Chair will be announced at the next meeting in April.

- Kendal Clark announced that the State is proposing a \$63 million dollar cut to the HOPWA funding.
- Kendall also talked about patients who are experiencing long-term survivor syndrome, a new mental health disorder, which is being called the AIDS Survivor Syndrome (PTSD). He stated that further discussions need to occur about this disorder.
