Continuum of Care (COC) – Support Staff provided the update.

6. Old Business

- Refine topic and discuss methodology for the FY'24 Needs Assessment Update.
 - The committee decided on 2 topics that would focus on the newly diagnosed and undocumented individual during the December meeting.
 - With respect to undocumented Ryan White individuals, Postel noted, the need assessment survey should be a simple check list given to the providers, listing services provided or unmet needs for RW client.
 - Postel stated there were concerns raised in the December CIA meeting about the linkage to care for the mental health of the newly diagnosed. The consumers suggested that there should be a focus on an increase in mental health support as soon as the client is given the news of their newly diagnoses.
 - Postel also mentioned the next steps would include creating a brief qualitative needs assessment survey to evaluate the needs of the newly diagnosed, listing questions geared to address possible mental health concerns.
 - Postel also mentioned the creation of the Needs Assessment survey should be completed and finalized during the February meeting. Committee members agreed the launch date of the Needs Assessment survey would be available to Ryan White clients by July 31st.
 - Postel mentioned both demographic profile for the undocumented and newly diagnosed as of December 31st, 2022, and Oct 31st, 2023, shows an increase of the total number of undocumented individuals by 27% and an increase of the newly diagnosed from 11% to 14%.
 - Bagchi suggested that the committee refer to prior surveys created to act as a guide in creating the Needs Assessment survey and then converted to survey monkey.
 - Lastly, Postel mentioned demographic reports will be emailed to all the committee members for review.

7. New Business

 - The committee decided to continue the review of the FY'24 workplan calendar for further discussion when the committee has quorum.
