Feedback from the Need Assessment discussion:

- Postel requested feedback from the CIA in the needs assessment topic of aging. The purpose of the
 needs assessment is to identify services that people living with HIV/AIDS need and the gaps. Postel
 mentioned that the needs assessment can identify to fill those gaps with Ryan White funding. The
 needs assessment is mandatory in federal law, and the information is needed. Postel mentioned
 that over 70% of the EMA are age 40 and over.
 - Insurance and comorbidities that come along with aging. Include others related health issues in the survey and comorbidities that may or may not be related to HIV?
 - Abdulwaliyy added the need of funding Durable medical equipment. Postel informed the committee of the new home and community-based service standard. This will include hearing aids, walkers, wheelchairs, etc.
 - The community needs more food pantries that serve food and vegetables for people living with HIV. Warren informed the committee that St. Michael has a pantry more specific for people living with HIV. The majority are now open to the public.
