Cancellation of Elections

The secondary legislation postponing the parish and town council elections from 2019 to 2020 was laid in parliament on Wednesday (see previous eUpdate newsletters for all the background [Northamptonshire \(Changes to Years of Elections\) Order 2018](#))

postpones all elections due to be held in May 2019, including borough, district and parish. The order comes into force on 14 January 2019.

We will require proof of entity which could either be copy of report and accounts where the charity is mentioned if associated with the church, registration with HMRC or a copy of the constitution.
