VILLAGE OF PEMBERVILLE COUNCIL MEETING September 16, 2025

Mayor Bailey opened September 16, 2025, Council meeting at 7:00pm with a prayer and the pledge of allegiance.

Roll Call: Present at the scheduled meeting of the Council were Angel, Kirkbride, Mazur, Rahe, Rollins, Titkemeier. Others present were Chief Vaughn, Eric Campbell, Ed Wozniak Jr., Teri Long, Linda Avery, Matt Bohland, Lisa Boyer, Marcia Cousino, Jen Fruth, and the Fiscal Officer.

Minutes: Titkemeier moved, and Rollins seconded to approve the minutes of the September 2, 2025, meeting. Motion passed unanimously.

Treasurer's Report: Rahe moved, and Mazur seconded to approve the bills in the amount of \$3,855.58. Motion passed unanimously. (Bill listing attached)

Rollins moved, and Titkemeier seconded to approve Ordinance 1693. Motion passed unanimously.

Police Activity Report: Activity report provided. No comments (attached)

Mayor

The Mayor reported that Brew Hop went well with no issues. Mayor stated that there is a Zoning Board of Appeals meeting scheduled for October 2nd at 6:00pm.

Mayor and Council discussed plans for Halloween. After further discussion, Rahe moved and Mazur seconded to reschedule Trick-or-Treat to Thursday, October 30th, from 6:00pm to 7:30pm. The motion carried.

Mayor stated that she had put together a packet of information from the Wood County Park District outlining the process they are taking to maintain their prairie at Harrison Park. A discussion ensued regarding the approaches detailed in the material, their timeline, and what seed mixes where used when in the prairie. Several residents voiced concerns regarding the ongoing issue of noxious weeds at Harrison Park behind their properties. They expressed frustration, feeling that little progress was being made to address the problem, and urged Council to take more decisive action. (attached)

Council Reports:

Rollins:

<u>Personnel & Finance Committee:</u> Rollins reported that the committee met to discuss the street department job description and requirements.

Rollins further stated that the Finance committee reviewed the budget by line item, with minor cuts being discussed. The committee emphasized the importance of timely submissions, noting that budget request forms are due by October 1st.

Rahe inquired about the 5-mile financial report that had been provided to Council. The Fiscal Officer clarified that the report served for informational purposes only, noting that nearly all expenses had already been accounted for within the document. (attached)

Records: Rollins said the committee will resume sorting records. The next meeting is set for September 22 at 9:00am.

Titkemeier:

Planning Commission: No report due to no meeting.

<u>BPA:</u> Titkemeier reported that the BPA discussed a range of topics related to sewer, water, and electric services, noting that no formal action was required at this time. The board also addressed the importance of restarting safety courses at Woodville, and discussed the Countyline Co-op easement, emphasizing the need for signatures from both involved parties. Titkemeier further stated that the water tower has successfully passed required tests, with only minor tasks remaining before it can be filled.

Rahe:

Streets, Sidewalks, Lands & Building: Rahe stated that the committee met and discussed that the final agreement for logging Kahler woods has been signed. The committee is still waiting for a quote from Bergman regarding street patching. Rahe also mentioned the new F550 truck is nearing completion, currently in the final outfitting phase. The street department is preparing the leaf machine, anticipating the start of leaf pickup soon. The mower recorded 67 operational hours over the past month, indicating that mowing activities are winding down as the season changes. A closing list for the pool was also provided to the street department to ensure all tasks are completed. Additionally, the committee is awaiting Ryno Shield to paint the grey building. Rahe reported that she, along with Mazur, met with the Fair Board and presented a letter about vacating the grey building. She also addressed recent issues with the locks at the baseball concession stand, confirming that these concerns have now been resolved.

Mazur:

<u>Park and Rec</u>: Mazur provided an update on parks and recreation, announcing that a Special Park and Recreation meeting is scheduled for September 22nd at 7:00pm to gather input from residents regarding future developments in the park. WoJo's recently inspected the park restrooms to assess ventilation needs and will be submitting a quote for the necessary improvements, along with a separate quote for installing a hot water heater. The committee has identified four potential projects but plans to narrow the list to three for submission to the upcoming Wood County Park Grant application. Additionally, the group is evaluating the possibility of replacing the basketball court poles to enhance facility safety and usability. Mazur added that the next meeting will take place on October 27th at 10:00am.

Kirkbride:

<u>Cemetery:</u> Kirkbride reported that the Cemetery committee met and briefly discussed recent activity, noting that one cemetery plot was sold and approximately ten burials have taken place in the past nine months.

<u>Tree Committee:</u> Kirkbride reported that the Tree Committee met September 8th and addressed both old and new business. The committee reviewed a letter previously sent to 435 Pine St. and discussed the routine assessment of a tree at 320 E. Front, which is slated for possible removal within the next 15 months. Currently, 86 trees are being actively watered, and Kirkbride highlighted the importance of reaching out to the school to address four hazardous trees located on school property that require removal.

Under new business, Kirkbride shared that Jim Bowe generously donated a tiller to help loosen compacted mulch around trees. October 6th has been reserved for a community chipping day, and the next planting event for new trees is scheduled for October 14th. The committee noted that some trees have recently been donated and mentioned a slight reduction in the tree budget to meet the \$2 per capita guideline. The Marge Cox dedication plaque has arrived and will be installed soon. Attention was also drawn to a tree at the southwest corner of Pine and College, which has electrical lines running through its canopy, and a tree on Bond Street that is in need of trimming. The next Tree Committee meeting is set for October 13th at 7:00pm.

Angel: Absent

Eric Campbell: No report

Kirkbride moved and Titkemeier seconded to go into executive session to discuss the sale of public property. Motion passed unanimously.

Rahe moved and Rollins seconded to come out of executive session.

Good Afternoon Carol,

Thank you for your email about the discussion at your last village council meeting. It is surprising that so much of the discussion appears to have centered on noxious weeds. Attached is the most recent OAC Noxious weed list for your convenience. I appreciate the screenshots you sent but having it in one document should be easier for all. Also attached is the seed mix list that was used when the prairie was planted in 2020. As you will see, the Park District did not plant Canada Thistle or any other noxious weeds. Doing so would be counterproductive to our efforts to restore native plant species across the Park District. While there is Canada Thistle growing in the prairie, we have a very active management plan in place to control and kill it, and are making good progress in this regard.

Canada Thistle, along with many other plants on the noxious weed list, was brought to the US from Europe many decades ago. Unfortunately, it is a very aggressive plant that spreads through blowing seeds and root rhizomes. Property owners across Wood County and Ohio are in a near constant battle to control Canada Thistle. Drive along most any state, county, or township road, or railroad during the summer and you will see Canada Thistle – along with other noxious weeds. The Canada Thistle that we are battling at our site was likely in the soil when we purchased the property, or it blew onto the property from neighboring properties, or it was deposited on the site by flood waters and by birds.

In addition to the seed list from when the prairie was planted, attached are maps from both the original 2020 planting and the additional wildflowers that we planted along the border with our neighbors in 2021. I have attached a timeline document for the project that includes our ongoing management efforts. As for woody plant removal, the Park District does do winter mowing for select woody species control when conditions are suitable to do so. Our natural resources staff makes that determination each winter.

Unfortunately, it appears that some of our neighbors believe that any plant that is not a turf grass species is a noxious weed. That is incorrect. We have made multiple attempts to explain this, including discussion about the purpose and benefits of a prairie at our Prairie Update Meeting in July. The native plants on site are no more of an invasive or noxious species than the sweetcorn growing across the street. While a couple of our neighbors believe it is humorous to refer to the prairie as a "weed patch" because it does not look like their yard, prairies are unique and complex ecosystems. They provide a rare native habitat for birds, butterflies, insects, reptiles, and other wildlife that live only in prairie environments. Established prairies contain deep, rich soil that is a dense tangle of roots and bulbs. Some prairie plants grow up to 9 feet tall and put out roots that extend 12 feet below the surface. Each year some of the root's die, allowing large quantities of organic matter to be added to the soil as they decompose, creating rich and fertile soil. The roots also act as pathways for water to enter the soil to recharge the ground water tables. They also act as a water filtration system, cleaning water as it passes underground.

Unfortunately, I have been told that we are not good neighbors because we will not allow our neighbors to mow the Park District's property. We agreed to provide a mowed buffer approximately 20 feet in width, and only after we had a survey done of the property line, did we discover that some of our neighbors had been mowing 30 to 35 feet of the park, including areas that had been seeded with prairie mix. In reestablishing the property line, we found piles of yard waste and project debris from the neighboring properties dumped in the prairie. This is simply unacceptable.

Apparently, at the Village Council meeting, one of the council members stated that "until the neighbors and the parks sit down and come to an agreement as to what is a noxious weed, there is no solution." The noxious weed list is determined by the State of Ohio. If your neighbor says they do not like a plant growing on your side of the fence, does that make it a noxious weed? Hardly.

Going forward, we will continue our plan of aggressively battling Canada Thistle, and any other noxious weeds that may appear on the site. We are working on laying out a future trail that will be mowed through the site to provide public access. The Park District acquired this property with grant money from the State of Ohio for the purpose of creating the prairie. Establishment of a prairie takes several years followed by on-going maintenance. In the long run, this will be a very positive project for Wood County.

Despite the aggressive behavior from some of our immediate neighbors, we will continue our peaceful and respectful approach to this project and should be able to expect the same from our neighbors.

William Henry Harrison Park Natural Area Expansion Project Timeline

Summer 2019- Park District was approached by the Beeker's to see if we were interested in purchasing the 32.81 acres of property immediately north of William Henry Harrison Park.

September 2019- The Board of Park Commissioners authorized participation in the Clean Ohio Greenspace Conservation program requesting \$225,000 towards purchasing the property for a cost of \$425,000.

October 2019- The Park District notified the Village of Pemberville about the intent to purchase the property if successful with the grant application and the plans to establish a prairie on site with future trails. The mayor responded with a letter of support for the project from him and Village Council.

November 2019- The Park District's Clean Ohio application was reviewed by the District 5 NRAC committee and scored the highest out of eight projects in that round of grant funding. The Park District was informed that funding was approved.

February 2020- The Park District successfully purchased the property with possession occurring once any crops are harvested later that year.

Summer 2020- Winter Wheat crop was harvested.

Fall 2020 - Site was treated and prepared for seeding.

November 2020 - Site was seeded with prairie mix.

Fall 2021 – Park District mowed the property line edge along the east portion of the property to address concerns about tall grasses falling over into neighbors' yards and to seed an additional forb/wildflower mix along eastern portion of the property.

Summer 2022 – The Park District began routinely mowing eastern edge of the property two mower widths at turf level to address neighbor concerns.

July 19th 2022 - The Portage River Water Trail is officially designated by the state. The Wood County Park District worked with the Toledo Metropolitan Area Council of Governments, U.S. Fish and Wildlife Service, Ohio Department of Natural Resources, and many other agencies to successful gain a trail designation for the waterway.

Summer 2023 – Area was spot mowed for thistle.

Spring/Summer 2024 – Area was spot treated with herbicide to address thistle. Larger areas were mowed then sprayed.

Spring/Summer 2025 — Area was spot treated with herbicide to address thistle. Larger areas were mowed then sprayed. Less thistle present than previous year.

Summer 2025 – Prairie Update Meeting. Additional foliar spray applications and mowing around village well heads. Worked with village to remove old well casing on site. These efforts will continue throughout the remainder of the 2025 growing season and will start up again during the 2026 growing season. We have marked a mowed buffer area along the eastern edge of the Park District's property and will continue to mow that for the remainder of the 2025 growing season.







Rule 901:5-37-01 Prohibited noxious weeds.

Effective: February 16, 2025
The following plants are hereby designated "prohibited noxious weeds":
(A) Shatter cane (Sorghum bicolor).
(B) Russian thistle (Salsola tragus).
(C) Johnsongrass (Sorghum halepense).
(D) Wild parsnip (Pastinaca sativa).
(E) Grapevines (Vitis spp.), when growing in groups of one hundred or more and not pruned, sprayed, cultivated, or otherwise maintained for two consecutive years.
(F) Canada thistle (Cirsium arvense).
(G) Poison hemlock (Conium maculatum).
(H) Cressleaf groundsel (Senecio glabellus).
(I) Musk thistle (Carduus nutans).
(J) Purple loosestrife (Lythrum salicaria).
(K) Mile-A-Minute Weed (Persicaria perfoliate).
(L) Giant Hogweed (Heracleum mantegazzianum).
(M) Apple of Peru (Nicandra physalodes).
