ONLINE PRIVACY POLICY AGREEMENT

Why We Collect Information and For How Long

- as required by law, or in response to a subpoena or search warrant;
- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of TransLux USA.

Non-Marketing Purposes

TransLux USA greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in TransLux USA products and services). In certain circumstances, we may use our website, newspapers, or other public means to post a notice.

Children under the age of 13

Notice to European Union Users
