

## XYZ Letter – Key Points – Jean Tricole (DOR: 12 September 2025)

### 1a. Full pension – (Option 1)

- Full pension of **£16,460.77 per annum** (including an excess pension of **£15,449.69 per annum** [which includes the excess transferred-in pension] and a post-1988 GMP [which includes the transferred-in benefit only] of **£1,016.08 per annum**)  
-----
- The excess pension of **£15,449.69 per annum** will be increased each year on 1 April by the lower of the increase in the Retail Prices Index and 5.0% (*pro-rated for the first year*)
- The post-1988 GMP of **£1,016.08 per annum** will be increased each year on 1 April by the lower of the increase in the Consumer Prices Index and 3.0%

OR

### 1b. Tax-free cash sum & residual pension – (Option 2)

- Tax-free cash sum of **£84,620.94** – [within both member's available 'LS&DBA' of **£1,073,100.00** and 'LSA' of **£268,275.00**]  
PLUS  
Residual pension of **£12,693.14 per annum** (including an excess pension of **£11,677.06 per annum** and a post-1988 GMP of **£1,016.08 per annum**)  
-----
- The excess pension of **£11,677.06 per annum** will be increased each year on 1 April by the lower of the increase in the Retail Prices Index and 5.0% (*pro-rated for the first year*)
- The post-1988 GMP of **£1,016.08 per annum** will be increased each year on 1 April by the lower of the increase in the Consumer Prices Index and 3.0%

## 2. Payment of pension

- The pension will be paid by monthly instalments in advance
- The first payment of pension will be made on **1 October 2025**
- The pension will be paid for life and will be subject to PAYE

## 3. Death in retirement

- If the member dies before 60 monthly instalments of pension have been paid, the balance of the 60 months (based on the rate of pension payable at the member's date of death) will be paid as a lump sum death benefit
- For both options, a spouse's pension will be payable on the death of the member of **£8,230.89 per annum** – (*these figures are before any annual increases are applied between the member's date of retirement and the member's date of death*)
- The spouse's pension will be paid for life and will be subject to PAYE

- Request a copy of the member's birth certificate
- Request the member's completed 'Option choice' form
- Request the member's completed 'Bank details' form
