

## **RST LEAVER – PRESERVED / CETV (WITH ENHANCED ACCRUAL)**

Letter to **YUKI NAMAKURA**

### **Key Points**

1. Date of leaving [DOL] (**15/09/2026**)
2. Preserved 'CARE' pension at DOL of **£21,368.68** per annum [versus 'Underpin' pension at DOL of **£19,855.33** per annum] [split pre 06/04/2006 = **£7,014.91** per annum and post 05/04/2006 = **£14,353.77** per annum]
3. Mention enhanced accrual rate for CARE pension
4. Normal Pension Date [NPD] (**11/01/2037**) or age (**65**)
5. Revaluation to NPD assumes rate of **2.5%** per annum compound ('true' annual revaluation rate will be **lower of 5.0% and CPI**)
6. Revalued pension at NPD of **£27,353.62** per annum [split pre 06/04/2006 = **£8,979.65** and post 05/04/2006 = **£18,373.97** per annum]
7. Tax-free cash sum option
8. Death before retirement lump sum death benefit (stating value of refund of contributions of **£51,463.19** payable to person(s) at the trustees' discretion)
9. Death after retirement spouse's / civil partner's pension of **£8,547.47** per annum at DOL (based on member's pension at DOL; split pre 06/04/2006 = **£2,805.96** per annum and post 05/04/2006 = **£5,741.51** per annum) revalued to **£10,941.45** per annum at NPD (based on member's pension at DOL, revalued to NPD; split pre 06/04/2006 = **£3,591.86** per annum and post 05/04/2006 = **£7,349.59** per annum)
10. Death after retirement lump sum death benefit (provided death occurs before reaching age 75 and before receiving 5 years of pension payments) equal to the lower of the balance of 5 years of pension payments or the unpaid balance of pension payments that would have been received up to the member's 75th birthday
11. If the member's spouse / civil partner at the date of the member's death is more than 10 years younger than the member, the pension will be reduced
12. Post retirement pension increases will be applied each year on the anniversary of the commencement of the member's pension
  - i. Pre 06/04/2006 pension will be increased each year by **5.0% (or RPI, if lower)**
  - ii. Post 05/04/2006 pension will be increased each year by **2.5% (or RPI, if lower)**
13. Transfer option
