  - 4-6 Type II Hand Crews: Vegetation/Fuels Management w/ masticator and excavator. On ground, ideally this Spring. They can keep doing fuels reduction during high fire season and backfill projects.
  - National Guard Training fuels management
  - o Work on S. Yuba Fuel Break on going: N slope of S. Fork.
  - o Ponderosa Way Fuel Break East to West fuel break.

 Truckee Fire Protection District has passed a new ordinance #01-2019 requiring a Defensible Space Inspection prior to close of escrow and eventual conformance to PRC4291. Will accept inspections up to 3 years prior. This could be a model for a similar future ordinance for the rest of Nevada County.
