Our Mission: The coalition promotes fire safety through advocacy, education, and community involvement with other stakeholders interested in working toward stronger fire safety practices.

Welcome & Announcements:

PG&E mandate to create 12 foot break under power lines – **PGE** has information about the 12 foot clearance under transmission lines. There is a link to the PGE requirements and options for dealing with PGE on the Coalition website. We have heard that there's been an update to the specifications since that article was written. Speaker

Patrick Mason: Nevada County Consolidated Fire role in road and unimproved property and defensible space

Nevada County Consolidated was established in 1991 with three districts, and is now up to 5 districts. Patrick originally work in suppression for 20 years, he is now involved with enforcement. He has authority over private roads and unimproved parcels. Process is complaint-driven – they do not have the staff to go out looking for violations. Complaint comes in, Patrick goes out to the property. In the County, road clearance requirements are: 10 feet outside the shoulder edge of the road, 15 feet high for rural roads (minimum). The focus is on the ladder fuels, not on the large trees. Look for small cedar, blackberry bushes, scotch broom etc. 10 ft is the minimum, pushing back further is recommended. Pushing hard now during the winter season, preparation for fire season The enforcement process: receive complaint, inspect, send letter, open up communication. After 30 days, second letter, another 30 days allowed for communication. After that the documents go to County Code enforcement, they handle the abatement. The way the code is written, if you complain and the owner of a property does not comply, you may be liable for 50% of the cost. Hopefully in March, the responsibility will shift directly to the property owner. Patrick is finding that most of the response is positive and people are taking care of the road clearance. On unimproved parcels we can request a 50 foot buffer from the property line. We may also request a fire break every 5 acres.

Evacuation Planning - Kent Rees

Cascade Shores sponsored an evacuation meeting. Cascade Shores is 6 miles east of town. There was an impressive turnout. We want to live with nature and big trees, and that bargain comes with the possibility of losing your home. We have asked NID to reconsider opening the gates that are now locked near Scotts Flat Lake. They also asked the county to remove the overhanging brush on Banner Lava Cap.. *Kent: The Coalition needs to make an appeal to the county that we need to be players in the operation. The Coalition represents the county. We should go on record with the roads department and that the Evacuation routes need to be the high priority. There is a genuine feeling of entrapment. The roads need to be opened up. A question arose about sheltering in place and what we can do right now. Jim Mathias: Areas of safe refuge is something we can do right now. A few houses that have defensible space that is well maintained makes for quick safe zones. Schools, airports, parking lots at shopping centers... The Coalition is one of the best avenues for making change in the county.*

The Coalition represents the county and is drafting a letter to the county offering our services. FSC has been working on road projects, they will share with the coalition.

Address signs – Remind your Firewise Community members to mount the green and white address signs. FSC has the signs for 40 dollars plus hardware. This may seem mundane but very important, also important for medical emergencies. Sign up for Code Red, it is important to be connected.

Assistance to Communities in Training – We are working with 18 communities that are trying to get their certification. The Coalition is looking for some volunteers to be a "mentor buddy" to these communities. Contact Bob Long if you can help.

Subcommittee Status Reports

Fire Safe council – Jamie Jones, Executive Director of the FSC. They have applied for the following grants: Cal Fire Grant, SNAP funds, grants for new FWC, Chipping grant, Green waste drop sites. County has requested funds for 100 miles of roads, with the 10-10-15, FSC will assist in this. We need to educate people on personal responsibility.

Evacuation - Chris Reilly – Working on Alert system and signage. Made request to improve ingress and egress routes from Alta Sierra with the county. Evacuation can include options for shelter in place. County is in process of improving vegetation management, hoping to obtain funding. Chris is encouraging community members to get involved in the process. Any road that can be used to get to a safe place needs to be maintained. The County said to submit road areas of concern. Kent Rees: *it is important to contact public works and get your voice heard, put your area in their sites.* Mike showed some signage they are working on. Signage that tells you what you need to do, posted in your garage. ASPOA website (Alta Sierra Home Owners) has them available. He also shared the signage, one that says I am out ok, one that says I need help. Coalition will make the signs available after further work..

Other: Scott Allen shared some sign mock-ups that could be available from Zumar https://www.zumar.com/: Shelter in Place (Red) or Evacuated (Green). No recommendation was made.
