Welcome and announcements – Bob Long – Attended the Fire Safe Council board meeting. They
have a budget for 2018–19 and they have a new chipper, funded by PGE. The FSC is where some
grant money comes, if a project isn't funded, it can be resubmitted. Coalition Firewise communities can help by organizing –shovel ready projects (organizing neighbors to decrease the
fuel load are the best), ready to act on, and submitting the plans for such projects to the FSC
to include in their grant proposals. The projects would be funneled through the Fire Safe
Council.

NFPA has information on Fire Adapted Communities that helps organize the communication with the county government about action towards more effective Fire Adapted Communities. Jackie Mason suggested that the Coalition create a committee that works on Fire Adapted Communities that would eventually present to the Supervisors, advocating change, more aggressive county involvement. Jackie and Fran Jorgensen will meet to discuss this and possibly move forward with a new Coalition committee.

- County Tax Bill Insert Status nothing new to report. There was some discussion and concern about renters not receiving the notice.
- Survey of "in training" FW Communities is ongoing. Continuing Survey of "How Do You Communicate with your Residents?" Please respond if you have not.
- By-Law Revisions, Presentation and voting Susan Rogers presented the proposed changes to the bylaws. Many of them were simple wording changes. - Emergency Alert Buddy System -- Virginia Gompertz Virginia experienced the Lake Wildwood fire, she went around to the neighbors and it took her about 2 hours to wake up the 27 neighbors.
