In some situations, withdrawal of consent may also deprive you of a benefit or service.

## 5. Limiting Use, Collection and Retention

We will use personal information for purposes for which it was collected, except with the consent of the individual or as required or permitted by law. We do not sell personal information to any organization or person for any reason. ### 6. Accuracy

# 7. Safeguards

## 8. Openness

We will make our policies and procedures with respect to management of personal information readily available to you and in a form that is generally understandable.

#### 9. Individual Access

You can request access to your personal information by making a request in writing at any time. Your request must provide us with sufficient detail to enable us with reasonable effort, to identify you and your personal information. Upon receiving your request, we will inform you within thirty (30) days of the existence, use, and disclosure of your personal information, and you shall be given access to that information, except where the law requires or permits us to deny access.

If you find any errors in your personal information, please contact us as soon as possible, and subject to receipt of satisfactory evidence, we will make the corrections immediately.

## 10. Recourse

We ask that you to contact us with any questions or concerns you might have. We will investigate and respond to questions about any aspect of our handling of your personal information.

The type of personal information we collect will depend on the service that we are providing to you. Personal information collected can include information establishing your identity (i.e., name, residential address, phone number, email address, date of birth, gender, identification documents); and information related to transactions arising from your relationship with us and/or our issuer clients.

## How is your Personal Information obtained?

The information we collect about you is received from:

- you directly;
- parties (i.e., lawyers, brokers, issuers) in respect of transactions being undertaken by issuers of which you are a registered securityholder;
- persons authorized to act on your behalf under a power of attorney or other legal authority; or
- government agencies and public registries.

It is your decision as to whether to provide us with your personal information. Do be advised however, that we may be limited in how we service you should you not provide us with information needed to fulfill your request.

# How is your Personal Information used?

We use personal information only for the reasonable purpose for which it was collected. Examples of how we use your personal information include:

- to verify your identity;
