Tours outside Namibian borders require a 30% non-refundable, non-transferable deposit. From time-to-time Jakkals Adventure Tours will also charge a fix amount depending on the type of tour as a deposit. The balance of the tour is due 30 days prior to departure. If a booking is cancelled with Jakkals Adventure Tours & Accessories cc, shall retain the full deposit. The transfer of your deposit to another client can only be granted by consent of the owner of Jakkals Adventure Tours & Accessories cc. All prices are quoted net of any financial transaction charges. Bank charges are the sole responsibility of the traveler.

# 3. Customer Privacy policy

Jakkals Adventure Tours & Accessories cc shall take all reasonable steps to protect the personal information of users.
