Summary

BCGC received funding through NTG - priority infrastructure grant to upgrade the community oval.

Comment

Works are almost complete on the oval project. HD pumps & irrigation have installed irrigation to the perimeter as well as the centre square of the oval. All irrigation works have now been commissioned. The turf has now been laid and is coming along well. According to the turf contractor; Turf NT, the grass will take approximately 2-3 months to be established enough before we are able to use the oval. If we access the oval before the grass is ready the grass will be destroyed and we will not achieve the desired result.

The steel benches have been completed by Ironbark Aboriginal Corporation utilizing local Belyuen residents and are ready for delivery. Some landscaping around the oval has also been completed. The spectator mounds are due to be completed early in the new year. 100 tons of road base is due to be delivered next week, this will be used for the mounds as well as various works in and around the oval.

Council, in collaboration with Ironbark Aboriginal Corporation have already provided training and activity generated income for approximately 12 local Indigenous residents who have expressed interest in the Belyuen Oval project.

Accredited civil works training has now commenced and is being delivered by Northern Territory Training Services. The training is spread over 2 months with the first two weeks already completed. Trainers will return to Belyuen to continue with the training in early January.

Power & Water have gifted Bore No.1 over to Council. We have transferred the bore over into our name and it is now operational. This is an important resource that is required to maintain water storage levels during the establishment of the oval.

The official opening of the community oval has been deferred until next year to allow for the turf to become established. This event is planned to coincide with Belyuen Cultural celebrations on January 25th.

Belyuen Council have numerous grant funded projects currently in progress. Council have also submitted several funding applications and are awaiting the results of those applications.

Comment

ABA:

In October, Council applied to the National Indigenous Australians Agency (NIAA) under the Aboriginals Benefit Account (ABA) for various grant funded projects. Correspondence from the Minister for Indigenous Australians, the Hon. Linda Burney was received on the 6th December detailing the outcome of the submissions.

While our submissions have been agreed in-principle only, it is a good result for Belyuen Council and the community. Negotiations will continue with NIAA to progress these projects in the new year.

FRRR:

In October, Council applied for funding through the Foundation for Rural & Regional Renewal - Strengthening Rural Communities to address food security issues currently experienced in the Belyuen Store. On the 29th November, we received correspondence advising that we were successful in the amount of \$20,000.

This project will commence in January next year and is estimated to be completed in February.

Community Benefit Fund:

In November, Council submitted a Vehicle Gift Application to the Northern Territory Government through the Community Benefit Fund to assist the Belyuen Culture program with service delivery. We received a response from the NTG on 23rd November stating that the funding round doesn't open until 1st January 2023, after which time Council will re-submit.

Celebrating Aboriginal Culture Day:

In October, Council received advice of a small grant funding opportunity: Celebrating Aboriginal Culture 2023. With support from Top End Women's Legal Service, (TEWLS) Council submitted an application to the value of \$5000. TEWLS have advised that Belyuen were successful to the amount of \$2,500.

This will still be sufficient funds to hold a cultural event on January 25th 2023.

International Womens Day:

In October, Council received correspondence from Member for Daly: Dheran Young regarding a funding opportunity for International Womens Day. The information was forwarded to the Belyuen Culture Coordinator and an application was submitted for \$3000 on the 10th November.

International Women's Day is held on 8 March each year, and is a global celebration of the social, economic, cultural, and political achievements of women. It also marks a call to action for accelerating women's equality.
