Northern Land Council – Section 19 Land Use Agreement Proposal

Summary

Correspondence received from the Northern Land Council on February 22nd addressed to the Belyuen Council CEO and the Minister for Local Government; the Hon. Chanston Paech.

The correspondence states that Belyuen Council owe the NLC rent for several lots occupied by the Council in Belyuen. The amount of rent requested by the NLC is \$110,300.00 plus interest per year backdated to 2012.

To resolve the issue, the NLC have requested a meeting with the Minister of Local Government and BCGC to discuss any amount owed plus interest and a commitment from BCGC to enter into section 19 land use agreements for 11 lots that BCGC occupy.

In the event that BCGC are unable to pay the amount of rent requested by the NLC, the NLC demand that BCGC vacate all lots that it currently occupies in Belyuen.

Belyuen Council responded to the correspondence from the NLC on March 3rd and again on March 6th inviting the Chair of the NLC; Mr. Samuel Bush-Blanasi and CEO Joe Martin-Jard to meet with Belyuen Council on either the 9th March or 28th March to resolve the matter.

Northern Territory Men's Places Grant

A grant of up to \$10,000 is available that can assist with improvement of the health and emotional wellbeing of men and forming community connections and support networks.

The purpose of the grant is to assist a range of activities such as information sessions, skills development, health and wellbeing programs, education and peer-to-peer support programs, parenting programs, and equipment. The application period has been extended and will close on 31 March 2023.

Community Place for People Grant

Community Place for People (CPP) grant program is an application based grant that enables regional and shire councils to apply for funding to establish more liveable spaces in their communities, and deliver initiatives that make public places attractive, comfortable, family-friendly and peaceful places to live and work.

Under the 2022-23 CPP program, \$2.8 million in total funding is available. There is only one funding round and applications should be for projects that are designed to create more liveable spaces in remote and regional communities which are consistent with council's annual/business plan. The total amount of funding requested in any single application cannot exceed \$415 000, and is to exclude administrative and management costs.

The closing date for CPP submissions is close of business 14 April 2023.

Summary

Belyuen Council have been approached by anthropologists and legal experts involved with the Kenbi Land Claim.

Comment

Earlier in March, Belyuen Council were contacted by Mrs. Kathryn Wells from the Australian National University regarding the storage and safekeeping of large volumes of archived material associated with the Kenbi Land case. Anthropologist Michael Walsh, Barrister David Parsons and Dean of Law Patrick Keyzer visited Belyuen on Wednesday 22nd March to meet with traditional owners and Belyuen family members to discuss the return of large quantities of archival material including recordings, video footage, photographs, transcripts and genealogy of Belyuen people.

The process of digitally cataloguing over 60,000 pieces of information is going to be an arduous task and it may be some time before the information is made available for cultural safekeeping here in Belyuen.

March has been a busy month for recruitment of local residents and engagement of new staff and contractors to assist with Belyuen Councils operational obligations.

Council have recruited numerous people in both temporary and permanent roles to assist with workload in various and numerous programs. Below is a list of new employees and their respective roles:

3. Dion Woodie: Labourer (casual)

There is also an opportunity to recruit locally to the Belyuen store via the school nutrition program and also in aged care to fill the vacant groundsman position.

As advised in the February meeting, Council have also engaged the services of Ironbark CDP participants to assist with grounds maintenance and community beautification projects throughout the community and surrounding area. The main tasks involve gamba and mission grass control as well as assisting with the development of the community oval.

Council have also identified a gap in the Aged & Disability program and have advertised for an Aged Care Team Leader to assist the Manager and existing staff with workload. The advertisement runs until the 17th April and is being advertised locally in community as well as on SEEK.

Once the advertisement closes, a panel will be nominated to shortlist applicants and conduct interviews. The recruitment process should be finalised by the end of April.

Sport & Recreation

The community oval is nearing completion with the new turf establishing well. The oval has been fertilized and mowed and is in good enough condition for limited access. Locals have commenced participating in various activities on the oval including softball and AFL training.

The sport and recreation program continues to grow with more engagement from the community participating in meaningful activities. A monthly S&R planner has been created which will inform the community of what activities will be available.

S&R will also be working closely with the Belyuen School to deliver a 6 week Auskick program. This is due to commence shortly once enough resources are acquired.

Council have also received funding for Belyuen to attend the 2023 Barunga Festival. The intention is to field a softball, AFL, Mens basketball and Womens basketball side at the festival. Expressions of interest from community residents will be sought at the next community meeting.

 - c) details of any material variances between the most recent actual income and expenditure of the council and the most recently adopted annual budget.
- 2) The report must also include:
 - a) details of all cash and investments held by the council (including money held in trust); and
 - b) the closing cash at bank balance split between tied and untied funds; and
 - c) a statement on trade debtors and a general indication of the age of the debts owed to the council; and
 - d) a statement on trade creditors and a general indication of the age of the debts owed by the council; and
 - e) a statement in relation to the council's payment and reporting obligations for GST, fringe benefits tax, PAYG withholding tax, superannuation and insurance; and
 - f) other information required by the council.
