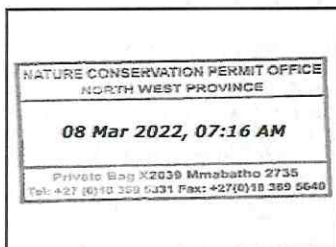

STANDARD CONDITIONS

ALL INTEGRATED PERMIT, STANDING PERMIT & REGISTRATION CERTIFICATE - FAUNA & FLORA

1) This permit is an "Integrated Permit", as defined of Chapter 1 and issued in terms of Chapter 2, Regulation 4 of the National Environmental Management: Biodiversity Act, 2004 (Act 10 of 2004): Threatened or Protected Species Regulations, and; 2) This permit is a "Standing Permit", as defined of Chapter 1 and issued in terms of Chapter 2, Regulation 18 of the National Environmental Management: Biodiversity Act, 2004 (Act 10 of 2004): Threatened or Protected Species Regulations, and; 3) This permit is also a "Registration Certificate", as defined in Chapter 1 and issued in terms of Chapter 3, Regulation 33(1) and (2) of the National Environmental Management: Biodiversity Act, 2004 (Act 10 of 2004): Threatened or Protected Species Regulations. 4) This permit is issued in terms of the Provisions of the Transvaal Nature Conservation Ordinance 12/83, Cape Nature Conservation Ordinance 19/74, the Bophuthatswana Conservation Act 3 of 1973. In terms of and subject to the Provisions of the Ordinances and Law and the Regulations framed there under the permit holder is hereby authorized subject to the conditions and requirements appearing on this permit to carry out the activity with the wild animals or plants as mentioned in the permit during the period of validity of this permit.

FACILITIES - ADDITIONAL CONDITIONS FOR LIVING ANIMALS - FACILITY & CARE OF ANIMALS

1) The permit holder : - a) may not keep animals in cages smaller than the prescribed cage sizes without the prior written approval from the Issuing Authority. b) may not use animals for any scientific research or experimentation, without the prior written approval from the Issuing Authority. c) may not conduct / perform any other restricted activity with any animal or derivative of such specimen, unless they are the holder of a permit issued by the Issuing Authority, whereby the permit holder is authorized to do so. (Note: the restricted activities authorised by this permit is limited to those specified under the heading "Restricted Activities and Methods and Instruments Permitted"). d) may only keep the species and numbers of animals specified on this permit for the express purpose for which the permit was issued. This does not include new additions to the register. e) may only keep the animals including young ones at the locality that appears on this permit and under no circumstances may any animal be kept elsewhere than in / at the approved facilities. f) must at all times ensure that all cages are kept in a good state of repair and are in accordance with all applicable legislation. g) must ensure that a post mortem be conducted on animals which die at the facility and a veterinary report is submitted to the Issuing Authority within 3 months. GENETIC CONTAMINATION 2) The permit holder : - a) must keep a stud book / register and submit to the issuing authority on a annual base as prescribed in the Regulations.. b) must ensure and prevent genetic contamination and inbreeding of any species. c) may not import, export, sell, donate, swap, exchange, trade in any way, any wild animal or any progeny of such wild animal, unless they are the holder of a permit issued by the Issuing Authority, whereby the permit holder is authorized to do so. d) must ensure that where DNA testing is required, the results of such testing are available upon request. e) Must ensure that all animals are micro chipped. 3) The permit holder must comply with the provisions of the facility's management plan. 4) This permit does not allow the handling, walking with, petting and any other direct interaction with the animals unless by management for management purposes.

FACILITIES - BREEDING FACILITY - CROCODILE

1) In the event of crocodile breeding or keeping facility any alteration that may trigger EIA compliance will render this permit invalid.

FACILITIES - STANDARD CONDITIONS

1) The permit holder may not without a permit: - trade, buy, sell, donate, receive, release, transport, import or export any animal / plant or derivative /progeny thereof. 2) The holder of the permit must on an ad hoc basis, apply for an ORDINARY Permit to carry out any additional / other restricted activity with any such specimen. 3) The permit holder must : - a) take all necessary and reasonable precautions to ensure the safety of the public and staff. b) at all times provide for the necessary public liability insurance. 4) The permit holder may not receive or keep any animals from the public without a permit issued by the Issuing Authority. 5) All animals destined for the hunting market may not be kept in a commercial exhibition facility.

FACILITIES - STANDARD REQUIREMENTS - MANAGEMENT


1) The permit holder must : - a) have an approved Management Plan for the facility. b) Ensure that changes to facilities design must be in accordance to the approved management plan. 2) All management plans are valid for a period of 6 (six) years, which after must be submitted for re-assessment and approval. b) notify the Issuing Authority of any plans to close down the facility, giving at least three months notice, prior to the closing down of the facility or the expiry of the permit. SPECIES RESTRICTIONS. 3) The permit holder may only : - a) keep / possess the exact species and not more than the numbers of animal / plant / derivatives and / or processed products as specified on this permit, where applicable. b) keep / possess the animal / plant / derivatives and / or processed products at the approved locality that appears on this permit. ACTIVITY RESTRICTIONS. 4) The permit holder may not : - a) utilize or provide any animal / plant / derivatives and / or processed products thereof for any illegal activities. b) utilize the animal / plant / derivatives and / or processed products for any other purpose except for with the permit was issued for. REGISTER, RECORDS & REPORTS 5) The permit holder : - a) must keep a stud book / register and submit to the issuing authority on a annual base as prescribed in the Regulations. 6) Any person who contravene or fail to comply with any of the conditions of the management plan, shall be guilty of an offence. 7) The Issuing Authority reserves the right to amend, withhold, withdraw or cancel any permit at any time, especially if the permit holder obviously neglects or fails to comply with any permit

GENERAL CONDITIONS - ALL PERMITS

1) This permit, unless otherwise stated, is only valid within the boundaries of the North West Province (hereafter named "the Province") and then specifically as specified on the permit. 2) This permit is valid only : - a) for the specific species, sex and numbers as specified on this permit. b) for the specific activity / activities authorised. c) for the specified methods or instruments authorised. d) for the specific property / locality as specified. e) for the specific day, time or period stipulated. 3) This permit is only deemed valid : - a) in the original format and with the content as issued by the Issuing Authority. b) once it has been printed and the signature of the permit holder has been endorsed thereon in ink. 4) the Issuing Authority reserves the right to amend, withhold, withdraw or cancel any permit at any time. 5) This permit is not transferable to any individual, natural person, juristic person or any other legal entity. 6) Any alterations or attempt thereto, whether electronically or in any other way, shall immediately render it invalid. 7) This permit shall lapse and be deemed invalid when it is altered, lost or destroyed and no copy thereof shall be issued. 8) This permit does not grant the permit holder automatic access to any Protected Area, National Park, Provincial Nature Reserve, tribal areas or privately owned land and : - a) the permit holder must beforehand obtain all other relevant written permissions, documents, rights and licences. b) the permit holder must comply with any other / further conditions or restrictions that the manager / landowner may stipulate at their discretion. 9) The permit holder must at all times while performing any restricted activity authorised by this permit, have the permit and all other relevant documentation in their possession and without delay make it available upon request by any authorized person. 10) An authorized person must also be allowed access onto the property at any reasonable time for any inspection needed and can remain on such property as long as it is needed to do the inspection. 11) The permit holder must immediately after completion of any activity authorised by this permit, record the required particulars in the space provided therefore or on the annexure or document attached hereto or in the prescribed register related to the permit. 12) The permit holder must return the original signed permit to the Issuing Authority within (14) fourteen days: - a) after performing or completing the authorised restricted activity, or b) after the date of expiry thereof whichever happens first, and c) if applicable furnish the Issuing Authority with a prescribed written feedback report on the results of every activity conducted. 13) The permit holder must retain a copy of the permit together with all other relevant written permissions, documents, rights and licenses for a period of at least (2) two years from date of issue or for as long as the permit holder is in possession of the animal, plant or derivative, whichever period is the longer. 14) If applicable, the permit holder shall apply for the renewal of the permit to the Issuing Authority, on the appropriate application form, at least (3) three months prior to the expiry date thereof. 15) This permit, during the period of validity thereof, is also subject to: - a) all applicable norms and standards in existence at the time of issuance. b) the provisions of any law in force, in respect of the specific species, activity, method or instrument to which this permit applies. 16) It is the permit holder's responsibility to obtain the correct information on any other legislation, specification, requirement or changes thereto that may be applicable or are required by any other Issuing Authority / Organization / Institute, relating to this permit. 17) By signing this permit, the permit holder declares that they are aware of the fact that : - a) any transgression or failure to render the required reports can lead to criminal prosecution and also jeopardize any future applications by or in the name of the permit holder. b) if the permit holder contravenes or fails to comply with any permit condition or requirement, they shall be guilty of an offence. 18) The prescribed fees paid to the Issuing Authority for the issue of this permit shall not be refunded.


