A STREET ADDRESS NUMBERING SYSTEM; ADDRESS

APR 17 POSTING REQUIREMENTS AND ENFORCEMENT PROCEDURES
FOR THE BOROUGH OF ALBA

BE IT AND IT IS HEREBY ORDAINED by the Borough of Alba that the following ordinance is adopted to provide for an orderly method of naming and numbering public and private streets and roadways in the Borough of Alba.

I. PURPOSE

PLANDERS COMMISSION

The purpose of this ordinance is to better enhance the County of Bradford E 9-1-1/Emergency Communications System and to provide for a uniform county-wide addressing system with respect to naming of streets and roadways; fabrication, erection and maintenance of street name signs; address posting requirements; enforcement procedures; and assigning street or house numbers to all residences and principal buildings and businesses to asst fire, rescue, ambulance companies, law enforcement agencies, the United States Postal Service, and the public in the timely and efficient provision of services to residences and businesses of Bradford County.

II. IMPLEMENTATION AND ADMINISTRATION

The implementation of the uniform standards for naming streets and an addressing system is in conjunction with the County of Bradford and the Bradford County "9-1-1 Emergency Communications System". This ordinance is established in conjunction with the County of Bradford in implementing and developing a "Master Street Address Guide" and coordinating, designating and naming of addresses pursuant to the street naming and address policy. Enforcement of the ordinance shall remain the responsibility of the Borough of Alba, however, the County of Bradford shall coordinate and assist the Borough of Alba in enforcement.

III. GUIDELINES AND STANDARDS

The Borough of Alba shall establish street names as chosen by the Borough of Alba, or land developer or land owner. And street or house numbers in accordance with the guidelines as set forth and described in Exhibit "A": BRADFORD COUNTY STREET NAMING AND ADDRESSING POLICY. Establishment of any street names and addresses will be coordinated with the County of Bradford pursuant to the Street Naming and Addressing Policy. Designation of street names and addresses by the Borough of Alba shall require the approval of the County of Bradford so as to coordinate such designations and to comply with the COUNTY OF BRADFORD STREET NAMING AND ADDRESSING POLICY.

IV. ENFORCEMENT

- A. Whenever the Borough of Alba has reason to believe there has been a violation of any provision of this ordinance, the Borough of Alba, or the designee of the Borough of Alba, shall give notice to the person or party failing to comply and order said person or party to take corrective action or measures within thirty (30) days from the date of notification.
- B. If such person or party fails to comply with the duly issued order, the Borough of Alba, or the designee of the Borough of Alba, shall initiate necessary actions to terminate the violation through criminal and/or civil measures.
- C. Penalties Any violation of any provision of this ordinance pursuant to any criminal section shall constitute a summary offense, punishable by a maximum fine of \$300.00 per offense. Subsequent to the thirty (30) day period following a violation, each day of violation shall constitute a separate violation. Should pursuant to this section, enforcement be by civil measures, any civil sanctions to be imposed shall be at a similar rate to the criminal amount of a maximum of \$300.00 per offense with each day of violation constitution a separate violation.

This Ordinance shall become effective immediately.
