Commissioner Doug Mcklinko was contacted about the lack of guard rails along the side of the bridge on route 14. The commissioner contacted PennDot and said that there should be guard rails installed in a couple of weeks. If it is not fixed, then Ron Colton will contact the Commissioner again.

New Business:

A representative from First Citizens Community Bank reached out about switching our accounts to their bank. She is willing to attend a meeting if the board would like to hear more about what they can provide for us. There was no interest in switching banks at this time.

The Deed for Alba Park was completed and received. It will be filed with the borough's documents.

Berger delivered gravel to the Alba Postal boxes. The gravel was requested prior, but Berger did not have his equipment to complete the task at that time. In the interim, the board received gravel from Bristol Excavating. There was no charge from Berger since there was a misunderstanding between the two parties.

There have been a couple of complaints about neighborhood dogs' poop not being cleaned up from other neighbors' lawns. Carol Bastion will address the offenders and if it continues the board will write a letter to those who make such an offense.
