In order to smoothly clear you in Greece please forward to us at least a day before your arrival the below required documents / certificates :

- **Yacht Registry**
- **Valid Insurance**
For Yachts under 300 Gross Tonnage | As per Annex I
For Yachts over 300 Gross Tonnage P&I is required
- **Passports**
If you are not an EU Citizen or Resident and your Nationality Falls Under the VISA Requirement please check if your VISA is in good order .
- **Seaman Books**
In case you have Seamen Onboard who are Non-EU Nationals and Have no VISA in their Passports please forward their Seaman Books .
Accepted Seaman Books are the ones Issued according to ILO .
Please send a copy by Whatsapp / Viber to check it for you

Other Documents Required in case the Yacht Belongs to a Third Person or Company

COMPANY OWNED YACHTS

In case the yacht belongs to a Company / Corporation please have with you the document or certificate that shows that on board is the owner or co-owner of the yacht .

If such document does not exist then kindly have with you an original stamped and signed by the company owner POWER OF ATTORNEY or LETTER OF AUTHORITY to Use the Yacht

YACHT OWNED BY THIRD PERSON

In case the yacht belongs to a Third Person then kindly have with you an original stamped and signed by the yacht owner POWER OF ATTORNEY or LETTER OF AUTHORITY to Use the Yacht

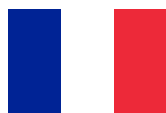
(*)The Recreational and Daily Tour Cruise Ships Fee (TEPAI)

The Recreational and Daily Tour Cruise Ships Fee (TEPAI) is imposed on all private and professional leisure ships and professional tourist day ships, of a total length of over 7m, regardless of flag, in Greek territorial waters.

UPDATED ACCORDING TO LAW 4926/22

For yachts **less than 300 Gross tonnage, the lower minimum coverage limits per risk, that will apply from June 1 / 2022** are as follows:

- a. Civil liability for death or personal injury of passengers and third parties: one hundred and fifty thousand (150.000) euros, per person and seven hundred thousand (700.000) euros, per incident and two million one hundred thousand (2.100.000) euros in total for the entire insurance period.
- b. Civil liability for material damages of passengers and third parties: one hundred and fifty thousand (150.000) euros, per event and four hundred and fifty thousand (450.000) euros in total for the entire insurance period
- c. Civil liability for sea water pollution: one hundred and fifty thousand (150.000) euros, per event and four hundred and fifty thousand (450.000) euros in total for the entire insurance period

- Kindly ask your insurance company to issue an Attestation
