NANAIMO PICKLEBALL CLUB – 2025 AGM MEETING MINUTES January 25, 2025

CALL TO ORDER: Meeting called to order Sat., Jan. 25, 2025 at 1:00 pm with President Deb Marshall chairing. This was a virtual meeting using Zoom.

QUORUM DETERMINATION: There were 36 members in attendance; with a current roster of 292 members, this exceeds the 5% requirement of 15 members present in order to achieve a Quorum.

Question: \$5k set aside for Beban Field House development as a facility a number of years ago; what is the status of this initiative? *Answer:* these funds were set aside several years ago and were meant to be used as a case study which was not undertaken so this commitment was not carried forward as a specific line item in the 2024 budget. We currently have a sufficient surplus to cover the costs of this initiative if it is pursued.

Club Ratings Committee: Lyle

Pickleball Brackets has recently changed significantly so our ability to monitor Novice (and other) players' ratings and move them up as appropriate no longer exists; Pickleball Tournament and Pickleball Brackets have been merged; as a result, the Club's Bracket Sessions have been temporarily suspended; novices can still access the Challenge Up Sessions and new options for moving up to 3.5 and 4.0 are anticipated. Something the new Executive will be addressing soon.

QUESTION: Are we going to DUPR? *Answer:* DUPR is an option under CourtReserve); much more work involved in data entry and management, so a move to DUPR in the short term is not likely.

New Member Liaison/Coordinator: Ruth – see report.

QUESTION: Are we keeping pace with the general increase in membership across the province related to the general increased interest in Pball or should we be actively recruiting members? *Answer:* We grew 10% from 2023 to close to 400 members at the end of 2024; currently (Jan. 2025) we are closer to 300 but this is not unusual as up to one third of members tend to sign up during the year rather than right at the beginning. We also have a lot of good outdoor options and there are many hardcore players that only play outdoors that aren't members.

QUESTION: Should we go after these folks to become members? *Answer:* We are already maxxed out at our indoor play options and may need to actually consider capping membership to reduce frustrations at not finding sufficient indoor play availability.

QUESTION: Is What's App a way to coordinate outdoor play? *Answer:* Likely need specific permission from members to be included on the list, and there may be liability issues; a good topic to further investigate at the next Exec. Meeting.
