10 teams to Sunday Double Lift.

Top 3 from each day (picked first) and top 4 overall (best two runs). In the event of a handler placing with 3 dogs, 2 of their choice will go forward to the DL.

In order to compete at the WCST Double Lift or Nursery Finals, all handlers must have been a paid member of a provincial association <u>30 days PRIOR</u> to the commencement of the event. Members of provincial stock dog associations may not necessarily reside in the province; thus membership **not** residency determines eligibility.
