Summary

Save the Children is currently accepting applications for a Monitoring and Evaluation Lead for an anticipated USAID-funded Community-based Basic Education Activity in Mali. This 5-year cooperative agreement will improve early grade read and math skills of young learners with a focus on improving the quality of instruction boosting community demand, and broadening safe, equitable formal and non-formal education services. The goal of the project is to expand access to education pathways and improve reading and math outcomes, especially for girls and marginalized children in Mali.

The Monitoring & Evaluation (M&E) Lead develops, implements, and continuously improves Monitoring and Evaluation systems for all project activities. This individual is responsible for ensuring development and operationalization of high-quality monitoring, evaluation and learning (MEAL) systems and reporting on a large-scale USAID-funded education project. The M&E Lead will incorporate best practices to ensure information collected is accurate, timely and disseminated appropriately in high quality reports. The M&E Lead will also use these findings to improve the program and achieve the objectives. This individual will also be actively involved in promoting learning through documentation of lessons learned and developing approaches for community analysis and using data for making thoughtful decisions. The M&E lead will use both quantitative and qualitative methods to gather data for the project.

What You'll Be Doing (Essential Duties)

MONOTINING AND EVALUATION



Overall, the MEAL Lead will work to ensure the integration of monitoring, evaluation, accountability and learning into all aspects of program implementation. The incumbent will contribute to the quality of Save the Children's programs in Mali by working, among other things, to put in place an appropriate data management system that will allow the collection, entry, storage, analysis and visualization of project data online and offline. Develop, revise, and, ensure USAID's approval of, and implement the M&E Plan on an annual basis.

Specifically, the MEAL Lead will:

• Provide leadership, training and mentoring to develop M&E plans, M&E tools, survey design, methodology, and data analysis to assess program impact.

Develop systems for capturing and documenting data and relevant information on project activities, beneficiaries, outputs, outcomes, and impact.

Design methodology and coordinate research activities for project operations and assessments.

Effectively rollout M&E collection and reporting systems to all staff and partners through training, site visits, manuals, and other technical support as needed.

Capture appropriate cost and financial information to track money indicators, including benchmarking information to analyze program effectiveness and cost effective inputs.

Ensure programming is aligned to targets and indicators contained in project proposal, and use the information from the M&E systems and tools to improve the program effectiveness and desired outcomes.

Manage and support a rigorous evaluation or project performance, impact, and cost effectiveness, including coordinating mid-term and final evaluations, and supporting donor and external reviews.

Provide oversight, with support of senior project team, of MEAL budget and ensure effective and timely use of appropriate MEAL activities. Provide on-going support to maintain M&E systems; identify skill gaps and build capacity among project team.

Prepare high quality, accurate and timely reports for Save the Children, project partners and USAID as required.

Minimum five years' experience in monitoring and evaluation related to education, literacy, social transformation or other related fields.

 projects including ensuring approval of MEAL plan, reporting on approved education projects, and
 successfully completing annual data quality assessments.
- Strong analytical skills and an understanding of monitoring, evaluation and assessment tools to promote evidence-based learning that take into account gender and social inclusion dynamics
- Ability to analyze complex data and summarize it for a range of audiences.
- Ability to gain support from staff across teams and to build the capacity of others.
- Sound strategic thinking and planning skills, including ability to think creatively and innovate and to set priorities, manageable work plans and evaluate progress.
- Excellent interpersonal skills and demonstrated ability to lead and work effectively in team situations;
