

# **When Fear Becomes Law and Obedience Is Marketed as Order in a Parasitic Narcissistic Spiritual Impoverished Society**

A narcissistic, parasitic, self-victimized society sustains itself through drama, chaos, deception, and conflict designed not to resolve anything, but to drag others down into the same frequency of prideful ignorance, entitlement, insecurity, unworthiness and fear-based consciousness.

This society is built upon curated, fragmented egoic identities and thrives as a performative spectacle, a hollow circus that rewards self-betrayal, victimhood, and compliance. It praises and rewards those who abandon inner truth, authenticity, and inner authority to join herd-based duality emotional petty manipulative immature hollow egoic games, while demanding ever-expanding frameworks of laws, norms, rules, and regulations to control, punish and dominate others rather than govern the self grounded in truth, integrity, honor, and dignity.

Because this society lacks self-love, self-compassion, self-healing, self-accountability, integrity, truth, honor, courage, and discernment, it cannot look inward. It cannot face unresolved inner-child trauma, emotional immaturity, spiritual incoherence, impoverishment or the absence of authentic inner sovereignty. Self-reflection would expose and collapse the illusion it depends on to survive.

Rather than grow, heal, or transcend conditioning, this fear-based collective chooses obsession, attachment, projection, and parasitic enmeshment. It clings to suffering and identity-based collective victimhood, externalizing responsibility and demanding obedience to justify its own inner emptiness. Power is sought not through the embodiment of inner authentic sovereign truth, but through binding hollow regulation, secrecy, punishment, surveillance, coercion, control, and domination.

Thus emerges a dystopian, dysfunctional collective agreement system, economic, political, institutional, educational, and cultural, engineered to normalize fear, scarcity, compliance, and dependency. A hierarchical “Ponzi” structure disguised as order, safety, progress, democracy, and freedom, while rewarding subservience, obedience, and self-abandonment.

This parasitic herd system survives through the comfort, complacency, and mediocrity of the many, upheld by fragile, insecure “elites” and enforced by loyal “minions” who trade conscience for status, money, clout or proximity to false power.

Together, they commodify human life into labor, debt, consumption, and identity, reducing sovereign beings into numbers within a parasitic hollow dehumanizing machine, which they are conditioned to depend on for approval and survival.

What is revealed is not power, but spiritual, deep-rooted poverty. Not leadership, but false authority that feeds on fear. Not order, but disorder.

But this parasitic hollow societal system persists only through consent. The moment consent is withdrawn on an individual level, the parasitic collective illusion collapses.

An empowered, conscious, discerning, and authentic sovereign collective does not need external regulations; it needs to self-regulate and take ownership of its own energies.
