

How Societies Consent and Defend the Very Same Parasitic Exploitative Hierarchical People and Systems That Diminish and Dominate Them

Obedience becomes a quiet requirement for participation in society, compliant and submissive to those perceived as in positions of “leadership” or “authority”.

And over time, people adapt, because the corrupt parasitic institutionalized system is designed to make resistance feel costly and conformity feel safe, glorifying and rewarding an individual and collective subservience, submission to the liars’ delusional hollow “elite” club.

In these societal hollow narcissistic parasitic environments, individuals are treated not as sovereign beings, but as numbers, units to be managed, discarded, expected to justify themselves, prove their innocence to the paladins of the almighty justice system, and constantly validate their right to exist within the corrupt, tyrannical hierarchical systemic and endemic fear-based scarcity status quo.

The burden shifts. The parasitic hierarchical system does not prove its integrity, while an individual is forced to prove their innocence to the very same corrupt system that silence, suppress, oppress, and punishes anyone who dares to be authentic, embody its own sovereign inner authority, who do not bow, follow, comply, agree, consent, or outsource its own self-regulative, inner state self-responsibility, self-sovereign authentic truth, who do not compromise its inner authority to please or appease any corrupt, parasitic hollow exploitative middle mans and systems of domination, and that are hypocritically disguised as righteous, or above others.

Authority becomes a performative circus, a fake, dramatic, hollow, and petty show, projecting false power while rooted in insecurity, control, speculating, plotting in secrecy to indoctrinate and dominate the societal landscape, fearing losing influence and control over others.

Rules multiply. Policies tighten. Freedom becomes conditional, dependent on the hands of a few who dictate who is right and who is wrong, who is dangerous and who isn’t.

Those who question, who step outside, who do not keep in line, who refuse to self-abandon to maintain alignment with the corrupt, parasitic, soulless, binding, exploitative societal system, are labeled, monitored, discredited, punished, or pressured back into conformity.

Not always through overt punishment, but through subtle coercion:

Social exclusion. Reputation attacks. Economic pressure and conditioning. Psychological, physical, and emotional intimidation and coercion, because the major goal is not just control of behavior, but control of an individual and collective perception.

A parasitic hollow hierarchical societal system like this depends on one thing above all else:

Individual and collective participation, agreement, and consent. It requires individuals to internalize its rules, to police themselves, and others to suppress their own discernment in exchange for a false sense of identity, stability, belonging, or safety.

This is where the deepest loss occurs, not in external freedom, but in internal sovereignty.

Because when a person begins to doubt their own inner voice, question their own perception, or silence their own authentic truth and inner compass to avoid consequence...the system no longer needs to control them. They do it themselves.

But this structure has a limit. It cannot fully contain an individual who remains rooted in awareness, self-regulated, self-discerning, self-accountable, and conscious of its own inner state.

A person who sees clearly does not participate, entangle, or comply with parasitic, distorted illusions of anyone and anything.

A person who knows themselves deeply is not subservient and submissive to dysfunction.

A person who refuses to self-betray becomes difficult to control, influence, sway, or manipulate.

Not because they fight louder, but because they no longer participate in what diminishes their inner sovereign, authentic truth, and inner authority.

That is where the illusion begins to weaken, because control starts to fade the moment an individual withdraws unconscious consent and returns to self-awareness, discernment, accountability, and inner authority.

That is the quiet collapse of every system built on manufactured fear and scarcity.

This is how the architecture of oligarchical hollow tyranny bind individuals that agree and consent to be surveilled, controlled, dominated, and exploited by the very people and systems it believe and defend in order to justify a curated fragmented egoic identity, a false sense of belonging, a false sense of approval, self-abandoning and self-betraying the true authentic self to appease and please the hypocritical, corrupt, status quo, societal, hollow parasitic establishment.
