GUIDANCE NOTES

Full Registration Regulations may be downloaded from our web site.

- 1) All imported registered dogs (including those from the UK and Guernsey) must be registered with the KCJ
- 2) Application for registration can usually only be made when a dog has arrived in Jersey (and cleared quarantine if applicable)
- 3) The KCJ will only normally accept registration of dogs from Kennel Clubs with which it has a reciprocal agreement.
- 4) Dogs from countries without a reciprocal agreement will need to be considered by Committee BEFORE importation.
- 5) Only breeds recognised by The Kennel Club will normally be accepted for registration
- 6) No change of name will be accepted, except for the addition of an owner's affix.
- 7) A Litter born in Quarantine to a bitch remaining in Jersey will need her to be registered in Jersey and also the litter will need to be registered on Form KCJ 1.
- 8) The Committee cannot be held responsible for the accuracy of information provided by third parties.
