Procedure for Applying for Registered Club Show Licences

Applications for licences to be sent to Registered Club Liaison Officer (RCLO) of The Kennel Club of Jersey.

The Application must contain the following mandatory information & appropriate fees to be considered:

- Name & Address of Society
- Type of Competition & whether it is a DOY qualifier
- Regulations to be held under
- Number of Classes
- Date of Show
- Signed on behalf of the Society

The following optional information will be requested: -

- Venue of Show
- Name & Address of Judges

Once the application is received the RCLO will take the form to the next Committee meeting for approval. If the licence is approved they will then issue the licence & request an Officer of the Club to sign it. Once it has been stamped with the Club's seal it will then be posted to the Society.

By 1 November the Channel Islands Dog Of The Year qualifying spreadsheet must be sent to the Registered Clubs Liaison Officer fully completed.
