Report to Huntington HOA Board from Board Representative Tom Guequierre December 2021

I attended the Neighborhood Network Meeting on November 4**. I took a webinar Covering the HOA 2021 Legislative Update on November 5th. I attended the Communications Committee Meeting on November 12**. I attended the Huntington Dolard meeting on November 15**. I attended the ACC meeting on November 17**. I attended the Neighborhood Network Meeting on International Covering and meeting on November 18**.

The Regular Monthly KRCA Board meeting was held on Wednesday November 17th. 14 of the 15 Board members were present. Listed will be Items the Board took action on during the meeting along with some general Information.

General Information: Two persons announced that they would be recording the meeting.

Under Financial Reports: Through the end of October the HOA Budget is running about 126K favorable as salaries, grounds repairs and irrigation system repairs are running well below plan. The Clubhouse Budget is about 82k favorable as staff vacancies, clubhouse utilities and pool expenses are also below plan and account for much of this condition. The Board will reevaluate the use of any surplus funds after the end of the year. As reported in previous months much of surplus funds from the last two years have been applied to the 2022 budget resulting in on increase in our monthly Assessments may have to be raised to cover expenses at that time.

Under New business: A brief report was given on the North Spa renovation. Progress has been slow but it is moving forward. Hopefully all will be done by the end of the

Up next was a bid from Susan McCarthy Roofing Contractor for the repair and installation of the Clubhouse East wing roof. The Board approved the bid for a total of \$17,752 to be taken from reserves.

We were advised of the need to replace a work staff club Car. Flory did a great job obtaining a very favorable bid. The Board approved the bid from Jeffrey Allen Inc. for \$10,985.11.

Committee & Miscellaneous Information: The Revitalization of Clubhouse Ballroom & Space Allocation Committee presented their report. The delivery of the six 65" TV's is expected in November with installation yet to be arranged. Requested and Board approved the purchase of two Movember with installation and the cost of \$1,770 from operations. A Bid is being sought for the Drapes, Valances and Exit Door Blinds.

Reports were received from the ACC, Communications Committee, CERB and Emergency Preparedness Committee and Traffic Safety.

Reports were also received from the Traffic Safety Committee, Emergency Preparedness Committee and the Finance Committee.

Open Forum Information: A third Blue Comment box was added in the Main Lobby. The three-month trial program is in progress. So far, the number of comments has remained fairthy low.

A resident mentioned that a Crope Myris near the Sussex Entry Wall needed trimming, A resident complimented the recont Hallowen Dance but again compliained that three is no Holiday Dance near Christmas.
