1. ____ Training Fees: Client agrees to pay Trainer a nonrefundable fee in the amount of \$_____ for a package of _____ sessions to be paid at first session. All sessions must be completed within 6 months from the date of commencement of contract or they will be forfeited.
2. ____ Dog Health and Vaccinations: Client warrants that Dog is physically fit and in good health, and free of fleas, parasites and infectious diseases. Client must provide proof of vaccines prior to participating in group classes.
3. ____ Training Services: Trainer agrees to provide private lessons for Client and Dog on a lesson-by-lesson basis, the goal being to teach Client how to train and work with Dog. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation. Client understands that he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and constantly reinforce training being given to Dog.
4. ____ Cancellation Policy: If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, session fees are still due. For a package deal, the session will still be counted as one session.
5. ____ Release of Liability and Indemnification: Client expressly acknowledges and understands that Trainer's services will be provided in an environment where certain hazards may exist, including, but not limited to, debris in the training area, other animals and their owners, training equipment, water, and other natural hazards. Client expressly agrees to indemnify and hold harmless Trainer and Trainer's agents and to pay all losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any claims, demands, lawsuits, losses, costs or expenses, including attorney fees, arising out of or in connection with the provision of Trainer's services to Client and/or Dog.
6. ____ If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.
7. ____ At Trainer's sole election, Trainer's duties hereunder shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.
8. If Dog causes property damage, or bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages_____. Owner agrees to be solely responsible for any and all acts or behavior of Owner's pet while it is in the care of T.O.B. Dog Training.
9. ____ Owner specifically represents that they are the lawful and valid owner of the pet, free and clear of all liens and encumbrances.
10. ____ Owner specifically represents that the pet has not been exposed to rabies or distemper within 30 days prior to boarding.
11. ____ If the pet becomes ill or if the state of the animal's health otherwise requires attention, T.O.B. Dog Training, at its sole discretion, is authorized to engage the services of a veterinarian or arrange for other requisite attention to the animal up to and including \$500.00 or _____, whichever is greater. If a veterinarian determines that emergency treatment, which exceeds the authorized amount, is needed to save the animal's life or quality of life, and we cannot reach you or the Emergency Contact, we may authorize the veterinarian to perform the emergency treatment. Owner agrees to be responsible for all veterinary costs provided to your animal.

12.____ It is expressly agreed by Owner and T.O.B. Dog Training's that T.O.B. Dog Training's liability in no event exceeds the lesser of the current chattel value of a pet of the same species or the sum of \$200.00, whichever is less.

13.____ Owner agrees to release, indemnify, and hold harmless Full House from any and all manner of damages, claims, loss, liabilities, costs or expenses, including reasonable attorney's fees and related costs, arising out of or related to T.O.B. Dog Training's services, except which may arise from the gross negligence or intentional and willful misconduct of T.O.B. Dog Training, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to T.O.B. Dog Training (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

14.____ Force Majeure. Neither Owner nor T.O.B. Dog Training shall be responsible for failure or delay in performing its duties under this Agreement if such failure or delay is due to tornadoes, thunderstorms, fire, floods, drought, riot, war or other acts of nature.

15.____ Entire Agreement. This agreement, and any addendums attached, constitutes the entire agreement between the parties. All terms and conditions of this agreement shall be binding on the heirs, agents and assigns of Owner and T.O.B. Dog Training.
