§ 1 General provisions

1. These Terms and conditions specify the regulations of registration and participation in the 6th International Conference – Strategies toward Green Deal Implementation: Water, Raw Materials & Energy in Green Transition organised by the Mineral and Energy Economy Research Institute, Polish Academy of Sciences, J. Wybickiego 7A, 31-261 Cracow (hereinafter referred to as the organiser).
2. 6th International Conference – Strategies toward Green Deal Implementation: Water, Raw Materials & Energy in Green Transition was co-financed from the state budget, allocated by the Minister of Science and Higher Education under the Programme "Excellent Science II" (in Polish).
3. Participation in the conference is possible in two modes: online or on-site in Cracow.
4. Participation in the conference is free of charge.

§ 2 Conditions of participation

1. The condition for participation in the conference is to complete the registration form available on the Conference website (<https://www.greendeal-conference.eu/>) within the deadline set by the organiser and presented on the conference website.
2. The Participant chooses the form of participation at the registration stage (online or on-site in Cracow) and is obliged to participate in the Conference in accordance with the declared form of participation.
3. Conference participants may participate in one of the following ways, as declared by the participant at the registration stage:
 - a) as a listener,
 - b) by presenting a paper (oral presentation),
 - c) by presenting a poster.

§ 3 Conditions of participation in the form of a speech

1. Each Conference participant may be the author of one presentation (oral or poster).
2. The participant presenting a paper or poster has the right to choose the language of the presentation: Polish or English, in accordance with the information provided in the registration form.
3. The final qualification of a paper or poster for the Conference program rests with the Scientific Committee, which reserves the right to change the form of the presentation or refuse its acceptance.



4. The participant declares that the submitted work has not been presented anywhere before and that the authors have the right to the results presented in the work.

§ 4 Withdrawal from participation

1. In the event of withdrawal from participation in the Conference or from giving a speech, the participant is obliged to immediately inform the Organiser by e-mail no later than 7 days before the beginning of the Conference.
2. Failure to provide information about withdrawal may result in exclusion from participation in subsequent editions of the Conference.

§ 5 GDPR and image use

1. Conference participants consent to the collection and use of personal data, including receiving emails, for purposes related to the GreenDeal 2026 International Conference. The data will be processed by the Mineral and Energy Economy Research Institute, Polish Academy of Sciences (contact: biogenicrm@gmail.com).
2. Participants' personal data are processed solely for the organization and implementation of the Conference, including participant registration, organizational communication, and event documentation. Providing personal data is voluntary but necessary to participate in the Conference.
3. Conference participants consent to the use of their image, captured during the Conference (particularly in the form of photographs and video materials), for informational, promotional, and marketing purposes related to the Conference, including the publication of materials on websites, social media, and other promotional materials.

§ 6 Final provisions

1. These Regulations apply to the Participant and the Organiser from the date of registration of the Participant for the Conference until the Organiser completes all activities related to the Conference.
2. The Organiser reserves the right to make changes to the Conference program for organisational reasons.
