

North Darfur: The RSF Must Urgently Account for the Indiscriminate Killings and Injuring of Zamzam Camp IDPs in El-Fashir

The African Centre for Justice and Peace Studies (ACJPS) continues to strongly condemn the indiscriminate killings and injuring of Internally Displaced Persons (IDPs) residing in the Zamzam IDP camp by the paramilitary Rapid Support Forces (RSF), a party in the ongoing armed conflict in Sudan. We reiterate our calls for swift accountability for the arbitrary killings and injuries and for the provision of adequate and timely reparations to victims and their families. The belligerents must ensure that all civilians, especially IDPs, are guaranteed all their inherent rights by upholding regional and international human rights treaties ratified by Sudan. Finally, Sudanese authorities must genuinely and tangibly prioritize justice, accountability, and redress for all human rights violations committed in Sudan, including those perpetrated by national security forces.

The Zamzam IDP camp is located west of El Fashir City, the capital of North Darfur State in Sudan, which has undergone several failed attempts by the RSF to capture it since May 2023. It is the largest IDP camp in El Fashir, hosting approximately 600,000 IDPs who fled from various regions of Sudan following the outbreak of the ongoing conflict in April 2023 between the RSF and the Sudanese Armed Forces over a power struggle. The first attack on the camp by the RSF militias was launched around 2023. Since then, there have been multiple further attacks, including a shelling incident on 16 December 2024, followed by another attack on 11 January 2025, both resulting in seven and 17 fatalities, respectively, and several injuries.

In a very recent incident, on 11 February 2025, around midnight, RSF troops launched another attack on the ZamZam IDP camp after leaving their base at Gauz Bida, located roughly 20 kilometers from the camp. They arrived in approximately 50 military vehicles, attacking the camp from the southwest while randomly firing bullets into the air. This attack quickly advanced through the rest of the area before the troops set the camp market ablaze.

The civilians, primarily IDPs, fled to the western part of the camp, where it was relatively safe. Unfortunately, however, at least five people were killed while eight others sustained injuries, and eight more have remained unaccounted for since the attack. Those with minor injuries received first aid, while those with severe injuries were unable to access medical attention because the nearby Médecins Sans Frontières (MSF)-run clinic was non-functional. Shortly after the incident, MSF issued a statement stating, "MSF's field hospital in Zamzam is not well-equipped to handle trauma injuries that necessitate surgical operations. Moreover, the current situation prevents the referral of critically injured patients to the nearby Saudi hospital in El Fashir due to heavy gunfire

along the way...". An ACJPS on-ground monitor later informed us that the victims of the incident who needed surgery remained in the camp without help, desperately hoping that aid would come their way.

The next day, on February 12, 2025, at approximately 6:00 AM, RSF troops launched another attack on the ZamZam IDP camp from the same direction as the February 11th attack, crossing the already burned market. They continued to set fire to the remaining market structures and nearby shelters, burning them down too. This time, however, the attack was countered by a group of youths and joint forces comprising the Sudanese Armed Forces and Darfur Rebel forces under the umbrella of the Sudanese Liberation Army (SLA). The youth group received support from the Sudanese Armed Forces' Air Force unit, which intervened and effectively defeated the RSF, bringing the gunfight to a close at around 10:00 AM. This incident resulted in nine fatalities and 18 injuries.

As a background, the Zamzam IDP camp was established in 2003 to host internally displaced persons from various states in the Darfur region in the aftermath of the crisis between the Sudanese Armed Forces and a local militia known as the Janjaweed, which later transformed into the Border Guard Unit and is now known as the RSF. Most of the camp's residents are from the Zagawa tribe, along with several other groups that fled from areas such as Khazan Kadeed, Tawilla, Abu Delig, Abu Zeroqa, Tabit, and Koligi localities, which have now been occupied by new settlers since 2013 due to the displacement of residents to Zamzam camp. Initially, the camp accommodated around 250,000 residents at the outbreak of the current armed conflict, but that number has since grown as more people escaped El Fashir City to Zamzam for safety. The camp has also become an exit point for areas under SLA-Abdul Wahid Noor control, such as Jabal Marra and Khazan Jadeed.
