

Executive Summary: Crisis at Breaking Point

June 2025



URGENT: Sudan has reached a humanitarian tipping point. The conflict has entered its most dangerous phase, fueling 500,000+ new displacements in June alone, 90,000+ cholera cases, and systematic human rights abuses. This crisis now demands immediate international intervention as civilian infrastructure collapses and violence intensifies.

Critical Developments

Territorial crisis: RSF retreating from Khartoum, concentrating forces in West Kordofan and areas bordering Libya, with evidence of foreign involvement

Health emergency: Cholera outbreak spans 13 states with catastrophic conditions in El Fasher where sieges block critical aid

Legal collapse: Complete absence of judicial institutions creating lawlessness, impunity, and vulnerability for civilians



Human Impact

Mass displacement: Over 2 million displaced since April 2023, with forced evacuations in multiple regions including El Fasher

Targeted violence: Documented attacks on schools, hospitals, and markets causing hundreds of civilian casualties in June alone

Resource crisis: Critical shortages of food, water, and essential services putting millions at risk of starvation

Armed Conflict Status


- Armed clashes continue between SAF and RSF
- RSF retreats from Khartoum, shifts to West Kordofan
- RSF establishes new positions in Northern Sudan bordering Libya

m Government Tensions

- New PM claims control of Port Sudan
- RSF declares PM government "illegitimate"
- RSF vows to advance toward Nile Valley

© External Factors

- Libyan border: Signs of Haftar's forces intervention
- New alliance attempts in Nairobi fail to form alternative administration
- "Alliance for Transition" coalition forming with RSF involvement



Impact Assessment

Intensifying power struggles hinder peace efforts and worsen security for civilians. The fragmentation of political control has created humanitarian access challenges and protection vacuums. This has directly led to increased civilian casualties, disruption of essential services, and impediments to international aid delivery.

* Cholera Outbreak Progression

- First detected: South Darfur (June 12)
- Initial outbreak: 50 cases, 8 deaths in Reil village
- Rapid spread to East Darfur and Al-La'it in North Darfur
- Heavy rains contaminated water sources
- Spread facilitated by mass displacement

Secondary Disease Threats:

Rising dengue fever and malaria cases reported in displacement camps. Malnutrition increasing vulnerability to disease.

Healthcare System Collapse

- Medical infrastructure destroyed in conflict areas
- Critical shortage of medical personnel (80% fled)
- Mass vaccination campaigns disrupted since April 2023
- Medical supply chains completely severed in El Fasher
- UN medical facilities targeted (Al-Majlad Hospital airstrike)

Critical Hotspots El Fasher "Catastrophic" - Under siege with blocked aid South Darfur Reil village, Marla area - Initial outbreak origin North Darfur Al-Dein region - Rapidly spreading North Darfur Al-La'it district - Limited medical access

▲ WHO Emergency Declaration

"Without immediate humanitarian corridors and temporary halts to fighting, Sudan faces a catastrophic public health emergency. El Fasher's conditions are particularly dire, with siege conditions blocking critical aid deliveries." WHO has called for mass cholera vaccination campaigns and emergency medical facilities in displacement camps.

Human Rights Violations: A Pattern of Abuses

June 2025



June 2025 witnessed escalating human rights abuses across Sudan as conflict intensified. Documentation reveals systematic targeting of civilians through indiscriminate bombings, arbitrary detentions, enforced disappearances, and targeted killings. Both conflict parties show concerning patterns of violations against protected populations and civilian infrastructure.

Civilian Bombings & Attacks

- June 25: El-Tina Market Drone Strike
 - 15 civilians killed, 30 injured including displaced families
- June 21: Al-Majlad Hospital Airstrike
 - 41 killed, including Dr. Mawadda Rahmatullah Al-Nour
- June 9: Abu Zabad School Bombing
 - 8 killed (5 students), 9 injured during school hours
- **June 3: WFP Aid Convoy Attack**
 - 4 humanitarian workers killed while delivering assistance
- June 1: Al-Kuma Market Strike
 - 89 civilian casualties (killed and injured) during market day

Detentions & Disappearances

Arbitrary Arrests & Torture

- June 12: Fatima Al-Mahdi
 - University student arrested during anti-war protests in Khartoum
- **June 10: Ahmed Youssef (16)**
 - Found dead in RSF detention in Nyala showing signs of torture
- June 6: Dr. Hassan Hamza
 - Blue Nile University Deputy Chancellor detained without charges

Enforced Disappearances

- June 20: Red Crescent Team
 - Seven aid workers missing near Kadugli, South Kordofan
- **June 16: Bushara Brothers**
 - Forcibly disappeared from El Fasher to Al-Tina



PATTERN OF ABUSE: These documented incidents reveal systematic targeting of civilians, healthcare facilities, educational institutions, and humanitarian workers in clear violation of international humanitarian law and constitute potential war crimes.

June 2025



Judicial System Collapse

- Complete absence of judicial institutions nationwide since April 15, 2023
- No functioning courts or formal legal proceedings in most regions
- Absence of law enforcement agencies creating security vacuum

Functioning Judicial Institutions:

95% decrease since April 2023

△ Legal Services Crisis

- May 29, 2025: New fees imposed on legal services and criminal litigation
- June 15, 2025: Nationwide protests by Sudanese Bar Association
- Violent dispersal of lawyer protests; 12 attorneys arrested in Khartoum

Legal Aid Accessibility:

78% decrease in accessible services for displaced persons

Impact on Citizens

- Loss of Basic Legal Protections
 Especially for women, children, and displaced persons
- Growing Impunity

 For perpetrators of violence, theft, and human rights abuses
- "Tax on Justice"

 New legal fees create barriers for impoverished citizens

Functioning courts in conflict zones

1 Long-term Consequences

The collapse of governance and rule of law creates a dangerous environment where human rights violations occur with impunity. Without functioning judicial systems, civilians have no recourse for protection or justice. This governance vacuum enables perpetrators to act without fear of accountability, creating cycles of violence that disproportionately affect vulnerable populations and undermine any path to peace.





Humanitarian Impact: Displacement & Violation Trends


KEY FINDINGS:

June 2025 marks the **highest monthly displacement** (500,000) since conflict began, with violence patterns shifting to previously stable regions. Cholera now affects **13 of 18 states**, worsening the humanitarian crisis.

Sudan States - Crisis Severity:

North Darfur: Severe - El Fasher siege, cholera outbreak
South Darfur: Severe - Nyala bombings, cholera cases
West Darfur: Severe - Civilian targeted violence
East Darfur: Severe - Al-Dein cholera outbreak
Central Darfur: Severe - Displacement crisis
West Kordofan: Severe - New frontline fighting
North Kordofan: Moderate - El-Obeid shelling

South Kordofan: Moderate - Kadugli missing aid workers

Khartoum: Moderate - Infrastructure collapse

White Nile: Moderate - Displacement camp conditions

Blue Nile: Moderate - Arbitrary arrests

Sennar: Moderate - Limited healthcare access Gezira: Moderate - Food security concerns

Red Sea: Moderate - Port Sudan political tensions

Kassala: Moderate - Refugee influx

Gedaref: Moderate - Food security issues

River Nile: Moderate - RSF movement towards Libya Northern: Moderate - Border tensions with Libya

Humanitarian Context:

Over 2 million displaced since April 2023, with 500,000 new displacements in June 2025 alone. The highest monthly displacement figure since the conflict began, with violence intensifying in previously stable regions and cholera spreading to 13 states. El Fasher remains under siege with limited humanitarian access, creating catastrophic conditions for civilians.

Establish protected routes for food, medicine, and cholera vaccines to reach 90,000+ affected by disease outbreaks

REPEAL JUDICIAL FEES

Remove barriers to legal redress for victims of human rights violations seeking justice

G Global Accountability Measures

UN SECURITY COUNCIL ACTION

Implement immediate arms embargo on all parties and authorize crossborder aid deliveries with enforcement mechanisms

INTERNATIONAL CRIMINAL TRIBUNAL

Establish dedicated mechanism to investigate and prosecute documented war crimes and atrocities in Sudan

REGIONAL DIPLOMATIC PRESSURE

Coordinated African Union and neighboring states' economic pressure on conflict parties to enforce ceasefire
